21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. APPROPRIATION - OPERATING EXPENSES. There is hereby
24 appropriated, to the State Crime Laboratory, to be payable from the State
25 General Services Fund Account, for Operating Expenses of the State Crime
26 Laboratory which shall be supplemental and in addition to those funds
27 appropriated in Section 2 of Act 402 of 1999, the following:

3 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
4 this act shall be limited to the appropriation for such agency and funds made
5 available by law for the support of such appropriations; and the restrictions
6 of the State Purchasing Law, the General Accounting and Budgetary Procedures
7 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
8 Restrictions Act, or their successors, and other fiscal control laws of this
9 State, where applicable, and regulations promulgated by the Department of
10 Finance and Administration, as authorized by law, shall be strictly complied
11 with in disbursement of said funds.

13 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
14 that any funds disbursed under the authority of the appropriations contained
15 in this act shall be in compliance with the stated reasons for which this act
16 was adopted, as evidenced by the Agency Requests, Executive Recommendations
17 and Legislative Recommendations contained in the budget manuals prepared by
18 the Department of Finance and Administration, letters, or summarized oral
19 testimony in the official minutes of the Arkansas Legislative Council or Joint
20 Budget Committee which relate to its passage and adoption.

22 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
23 Assembly, that funds provided by the General Assembly for the operations of
24 the State Crime Laboratory are, due to unforeseen circumstances, insufficient
25 for the State Crime Laboratory to continue to provide essential governmental
26 services; that the provisions of this act will provide the necessary monies
27 for the State Crime Laboratory to continue such services; and that a delay in
28 the effective date of this Act could work irreparable harm upon the proper
29 administration and provision of essential governmental programs. Therefore, an
30 emergency is hereby declared to exist and this Act being necessary for the
31 immediate preservation of the public peace, health and safety shall be in full
32 force and effect from and after the date of its passage and approval. If the
33 bill is neither approved nor vetoed by the Governor, it shall become effective
34 on the expiration of the period of time during which the Governor may veto the
35 bill. If the bill is vetoed by the Governor and the veto is overridden, it
36 shall become effective on the date the last house overrides the veto.
