SECTION 3. LEGISLATIVE INTENT. SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
 Assembly, that the Constitution of the State of Arkansas prohibits the
 appropriation of funds for more than a two (2) year period; that the
 effectiveness of this Act on July 1, 2001 is essential to the operation of the

28 agency for which the appropriations in this Act are provided, and that in the

29 event of an extension of the Regular Session, the delay in the effective date
