13-7-306. Acquisition of additional property - Restoration.

12 (a) The Arkansas Territorial Capitol Restoration Commission <u>Historic</u> 13 <u>Arkansas Museum Commission</u> is authorized to acquire for and in the name of the 14 State of Arkansas, by purchase, gift, donation, or otherwise, the title to the 15 west one-half (1/2) of Block 32 of the Original City of Little Rock, Arkansas, 16 which adjoins the present property owned by the State of Arkansas upon which 17 the buildings housing the Arkansas Territorial Capitol and other historic 18 buildings and facilities are located.

(b) The commission is authorized to acquire for and in the name of the
 State of Arkansas, by purchase, gift, donation, or otherwise, the title to
 property which is adjacent to Block 32 of the Original City of Little Rock,
 Arkansas.

(b) (c) Upon acquiring title to the west one-half (1/2) of Block 32,
 the The commission may use it its property for and make improvements thereon
 as it deems to be in the furtherance of the aims and purposes of the
 commission as prescribed by law.

The Arkansas Territorial Capitol Restoration Commission <u>Historic</u> Arkansas Museum Commission is authorized to accept and receive any and all gifts, grants, donations, and contributions of real and personal property and to manage and use the property and the income therefrom for the construction, reconstruction, restoration, and maintenance of buildings or facilities and for other improvements on Block 32 of the Original City of Little Rock, the Territorial Capitol Restoration Grounds <u>the property</u>.
