

22	SECTION 1. Ark	ansas Code 12-8-104(a)(1), concerning	the appointment of
23	the Director of the Department of Arkansas State Police, is amended to read as		
24	follows:		
25	(a)(1) <u>(A)</u> The	Governor <u>, after conferring with the m</u>	embers of the
26	<u>Arkansas State Police</u>	<u>Commission</u> , shall appoint a Director	of the Department
27	of Arkansas State Pol	ice who shall be the executive and ad	ministrative head of
28	the department and sh	all receive a salary as fixed by law.	
29	<u>The director shall se</u>	rve at the pleasure of the	
30	<u>Governor.</u>

32	SECTION 2. <u>EME</u>	RGENCY. It is found and determined b	y the General
33	Assembly of the State of Arkansas that the Arkansas State Police is presently		
34	without a director; that without an emergency clause this act would not be		
35	effective until ninety (90) days after the adjournment sine die of the General		
36	Assembly; that a new	director should be appointed before t	<u>his act would take</u>

1	effect without an emergency clause; and that the members of the Arkansas State			
2	Police Commission should be consulted prior to that appointment. Therefore,			
3	an emergency is declared to exist and this act being immediately necessary for			
4	the preservation of the public peace, health and safety shall become effective			
5	on the date of its approval by the Governor. If the bill is neither approved			
6	nor vetoed by the Governor, it shall become effective on the expiration of the			
7	period of time during which the Governor may veto the bill. If the bill is			
8	vetoed by the Governor and the veto is overridden, it shall become effective			
9	on the date the last house overrides the veto.
