For An Act To Be Entitled

10 AN ACT TO PROHIBIT THE POSSESSION OR USE OF GLASS
11 CONTAINERS WITHIN THE BANKS OF ARKANSAS' NAVIGABLE
12 WATERWAYS; TO REQUIRE THAT COOLERS, ICE BOXES AND
13 OTHER CONTAINERS USED ON ARKANSAS' WATERWAYS FOR
14 TRANSPORTING FOOD AND BEVERAGES BE PROPERLY SEALED; TO
15 REQUIRE THAT ALL PERSONS FLOATING ARKANSAS' NAVIGABLE
16 WATERWAYS CARRY A CONTAINER ATTACHED TO THE VESSEL
17 SUITABLE FOR COLLECTING TRASH AND BEING SECURELY
18 CLOSED; TO REQUIRE THAT BEVERAGE CONTAINERS BE
19 PREVENTED FROM SINKING TO THE BOTTOM OF ARKANSAS'
20 NAVIGABLE WATERWAYS; AND FOR OTHER PURPOSES.

22 AN ACT TO PROHIBIT THE POSSESSION OR USE

28 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
29

30 SECTION 1. (a) Except for containers for substances prescribed by a
31 licensed physician, no person shall possess or use glass containers within the
32 banks of Arkansas's navigable waterways, within a vessel.

33 (b) All persons entering, traveling upon, or otherwise using Arkansas'
34 navigable waterways by canoe, kayak, inner tube or other vessel easily
35 susceptible to swamping, tipping, rolling or otherwise discharging its
36 contents into a waterway, and transporting a cooler, ice-box or other

1 container for foodstuffs and beverages shall:

2 (1) Assure that the container is made to seal or lock in the
3 contents to prevent the contents from spilling into the water;

4 (2) Carry and affix to the vessel, a container or bag suitable
5 for containing their refuse, waste and trash materials and capable of being
6 securely closed; the container or bag shall be of mesh construction;

7 (3) Transport all their refuse, waste and trash to a place where
8 the materials may be safely and lawfully disposed of;

9 (4) At all times other than when a beverage is securely contained
10 as in subdivision (1) through (3), keep the beverage attached to or held
11 within a floating holder or other device designed to prevent the beverage from
12 sinking beneath the surface of the waterway; and

13 (5) A container shall not be required for those persons traveling
14 without foodstuffs or beverages.

15 (c)(1) A violation of this act shall be a misdemeanor and each
16 violation may be prosecuted as a separate offense.

17 (2) Each violation shall be punishable by a fine of not more than
18 five hundred dollars (\$500).

19 (d) For purposes of this act, "navigable waterway" means any navigable
20 river, lake, or other body of water used, or susceptible to being used in its
21 natural condition by canoe, kayak, innertube, or other vessel easily
22 susceptible to swamping, tipping, or rolling, located wholly or partly within
23 this state.

24 (e) For purposes of this act "vessel" shall not include houseboat,
25 party barge, johnboat, runabout, ski boat, bass boat or similar craft not
26 easily susceptible to swamping, tipping or rolling.
