2	requirements of subsection (b) of this section, between October 1 and December		
3	31 of the preceding year.		
4	(2) The renewal application when filed renews the registration		
5	for the following calendar year.		
6	(e)(1) A foreign limited liability company whose registration is		
7	effective may thereafter qualify as a foreign limited liability company under		
8	the registered name or consent in writing to the use of that name by a limite		
9	liability company thereafter incorporated under this act or by another foreig		
10	limited liability company thereafter authorized to transact business in this		
11	state.		
12	(2) The registration terminates when the domestic limited		
13	liability company is incorporated or the foreign limited liability company		
14	qualifies or consents to the qualification of another foreign limited		
15	liability company under the registered name.
