

Arkansas Code 26-36-203 is amended to read as follows: 36

2	(a) No later than December 1 in each year, the collector of taxes shall			
3	prepare a list of delinquent personal property taxes and deliver a copy of the			
4	list to a legal newspaper of the county. Within seven (7) days thereafter,			
5	the newspaper shall publish <del>the first insertion of</del> the list <del>, which shall be</del>			
6	<del>published two (2) times in successive weeks</del> . The newspaper shall publish the			
7	list in at least seven (7) point size type. If the newspaper regularly			
8	publishes a total market coverage edition or supplement publication that has			
9	wider circulation within the county or district, the newspaper may publish the			
10	list <del>one (1) of the required two (2) times</del> in said edition or publication. If			
11	there is no newspaper in the county or district, the publication shall be in			
12	the nearest newspaper having a general circulation in the county or districts			
13	for which the list is being published.			
14	(b) The publication shall show, besides the name of the taxpayer, his			
15	school district and the total amount of taxes delinquent, including penalties.			
16	The publication shall be in substance as follows:

7	cost the sum of <del>seventy five cents (75¢)</del> <u>one dollar and twenty-five cents</u>
8	<u>(\$1.25)</u> per name, per insertion, which sum, together with fifty cents (50¢)
9	per name for the collector preparing and furnishing the list, shall be charged
10	to the delinquent taxpayer and shall be paid by the collector from any moneys
11	in his hands derived from payment of personal property taxes. The receipt for
12	such payment, verified by the certificate of the county clerk as to its
13	correctness, shall entitle the collector to a credit for the amount so paid.
14	(d) This section shall be cumulative to all existing laws relative to
15	the collection of personal property taxes.
