18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. Arkansas Code § 26-52-103(a)(3), pertaining to the		
21	definition of sale for purpose of the Arkansas Gross Receipts Act of 1941, is		
22	amended to add a new subdivision to read as follows:		
23	<u>(</u> F) "S	ale" shall not include the t	ransfer of title to a
24	vehicle by the vehicle owner to an insurance company as a result of the		
25	settlement of a claim for	damages to the vehicle.

27	SECTION 2. EMERGEN	CY CLAUSE. It is found and	determined by the
28	General Assembly of the State of Arkansas that current law excludes the		
29	transfer of a damaged vehicle to an insurance company from the definition of		
30	"sale" for purposes of gross receipts tax; that this definition is in need of		
31	clarification to ensure that the original legislative intent is fulfilled;		
32	and that this act is immediately necessary to prevent possible confusion		
33	among the taxpayers of Arkansas. Therefore, an emergency is declared to		
34	exist and this act being immediately necessary for the preservation of the		
35	public peace, health, and	safety shall become effecti	ve on:
36	(1) The date	of its approval by the Gove	ernor:

1	(2) If the bill is neither approved nor vetoed by the Governor,
2	the expiration of the period of time during which the Governor may veto the
3	<pre>bill; or</pre>
4	(3) If the bill is vetoed by the Governor and the veto is
