22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the
25 Assessment Coordination Department for the 2003-2005 biennium, the following
26 maximum number of regular employees whose salaries shall be governed by the
27 provisions of the Uniform Classification and Compensation Act (Arkansas Code
28 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
29 Provided, however, that any position to which a specific maximum annual
30 salary is set out herein in dollars, shall be exempt from the provisions of
31 said Uniform Classification and Compensation Act. All persons occupying
32 positions authorized herein are hereby governed by the provisions of the
33 Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101),
34 or its successor.

SECTION 2. EXTRA HELP. There is hereby authorized, for the Assessment Coordination Department for the 2003-2005 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: three (3) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

9 SECTION 6. APPROPRIATION - REAL PROPERTY REAPPRAISAL. There is hereby

10 appropriated, to the Assessment Coordination Department, to be payable from

11 the Arkansas Real Property Reappraisal Fund, for paying counties and

12 professional reappraisal companies for the cost of reappraisal of real

13 property for the biennial period ending June 30, 2005, the following:

20 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND

22 TRANSFER. To provide funding for the appropriations authorized herein, the

23 Director of the Assessment Coordination Department of the State of Arkansas

24 shall certify monthly to the Chief Fiscal Officer of the State, the amount of

25 funding needed each month to pay counties and professional reappraisal

26 companies for the reappraisal of real property as required by law. Upon

27 receipt of such certification the Chief Fiscal Officer of the State shall

28 transfer on his books and those of the State Treasurer 76% of the amounts

29 certified from the Department of Education Public School Fund Account, 16% of

30 the amount certified from the County Aid Fund, and 8% of the amount certified

31 from the Municipal Aid Fund to the Arkansas Real Property Reappraisal Fund.

32 In no event shall the total amount of funds transferred as authorized herein

33 exceed fourteen million two hundred fifty thousand dollars ~~(\$14,000,000)~~

34 (\$14,250,000) during each year of the ~~2001-03~~ 2003-05 biennium.

35 The provisions of this section shall be in effect only from ~~July 1, 2001~~

36 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

2 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
3 by this act shall be limited to the appropriation for such agency and funds
4 made available by law for the support of such appropriations; and the
5 restrictions of the State Purchasing Law, the General Accounting and
6 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
7 Procedures and Restrictions Act, or their successors, and other fiscal
8 control laws of this State, where applicable, and regulations promulgated by
9 the Department of Finance and Administration, as authorized by law, shall be
10 strictly complied with in disbursement of said funds.

11
12 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly
13 that any funds disbursed under the authority of the appropriations contained
14 in this act shall be in compliance with the stated reasons for which this act
15 was adopted, as evidenced by the Agency Requests, Executive Recommendations
16 and Legislative Recommendations contained in the budget manuals prepared by
17 the Department of Finance and Administration, letters, or summarized oral
18 testimony in the official minutes of the Arkansas Legislative Council or
19 Joint Budget Committee which relate to its passage and adoption.

20
21 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the General
22 Assembly, that the Constitution of the State of Arkansas prohibits the
23 appropriation of funds for more than a two (2) year period; that the
24 effectiveness of this Act on July 1, 2003 is essential to the operation of
25 the agency for which the appropriations in this Act are provided, and that in
26 the event of an extension of the Regular Session, the delay in the effective
27 date of this Act beyond July 1, 2003 could work irreparable harm upon the
28 proper administration and provision of essential governmental programs.
29 Therefore, an emergency is hereby declared to exist and this Act being
30 necessary for the immediate preservation of the public peace, health and
31 safety shall be in full force and effect from and after July 1, 2003.
