10	(3) A waiver described in subdivision (b)(1) or (b)(2) shall
11	not be enforceable unless contained in a separate document.
12	(c) A purchaser who refuses to sign a waiver described in subsection
13	(b) of this section shall not be denied the right to purchase a motor vehicle
14	at the price agreed upon by the purchaser and the seller.
