11 AGENCY TO IMPOSE FINES AGAINST HEALTH CARE
12 FACILITIES THAT FAIL TO PROVIDE REQUIRED HEALTH
13 CARE DATA; TO PROVIDE FOR LICENSE SUSPENSION FOR
14 CONTINUING VIOLATIONS OF THE REQUIREMENT TO
15 REPORT HEALTH CARE DATA; AND FOR OTHER PURPOSES.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. Arkansas Code § 20-8-110(c), concerning collection and
27 dissemination of health data by the Health Services Permit Agency, is amended
28 to read as follows:

29 (c) All hospitals, nursing homes, outpatient surgery centers, ~~and~~ home
30 health agencies, assisted living facilities, residential care facilities, and
31 hospices licensed by the state shall submit annually a report of utilization
32 statistics as may be required by the agency.
33

34 SECTION 2. Arkansas Code § 20-8-110, concerning collection and
35 dissemination of health data by the Health Services Permit Agency, is amended



1 to add an additional subsection to read as follows:

2 (i)(1) The agency may impose a fine on nursing homes, home health
3 agencies, assisted living facilities, residential care facilities, and
4 hospices for failure to timely submit reports of statistics as required by
5 the agency.

6 (2) The agency may impose a fine of:

7 (A) Up to one hundred dollars (\$100) for a report over
8 thirty (30) days late;

9 (B) Two hundred fifty dollars (\$250) for a report over
10 sixty (60) days late; and

11 (C) Five hundred dollars (\$500) for a report over ninety
12 (90) days late.
