1 Funding for the minimum compensation provided for in this section that is supported in whole or in part from general revenues, shall, if required, be 2 provided by a transfer from the Merit Adjustment Fund to the proper fund or 3 4 fund account and in such amounts as determined by the Chief Fiscal Officer of the State. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the 31 32 appropriation of funds for more than a two (2) year period; that the 33 effectiveness of this Act on July 1, 2005 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in 34 35 the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2005 could work irreparable harm upon the 36

1	proper administration and provision of essential governmental programs.
2	Therefore, an emergency is hereby declared to exist and this Act being
3	necessary for the immediate preservation of the public peace, health and
4	safety shall be in full force and effect from and after July 1, 2005.
