28	(4) An insurer or lessor of a motor vehicle shall not require an
29	owner to provide written permission for the access or retrieval of
30	information from a motor vehicle event data recorder as a condition of the
31	policy or lease.
32	(f) Except as specifically provided under subsections (d), (g), (h),
33	and (i) of this section, the data from a motor vehicle event data recorder
34	shall only be produced without the consent of the owner at the time of the
35	accident if:
36	(1) A court of competent jurisdiction in Arkansas orders the

8	(g) The Arkansas State Highway and Transportation Department may
9	retrieve data from a motor vehicle event data recorder if the data is used

13	the United States Department of Transportation;
14	(3) Replacing handwritten reports for any fuel tax reporting or
15	other mileage reporting purpose; or
16	(4) Complying with a state or federal law.
17	(h) To protect the public health, welfare, and safety, the following
18	exceptions shall be allowed regarding the retrieval of data from a motor
19	vehicle event data recorder:
20	(1) To determine the need or facilitate emergency medical care
21	for the driver or passenger of a motor vehicle that is involved in a motor
22	vehicle crash or other emergency, including obtaining data from a company
23	that provides subscription services to the owners of motor vehicles for in-
24	vehicle safety and security communications systems;
25	(2) To facilitate medical research of the human body's reaction
26	to motor vehicle crashes if:
27	(i) The identity of the owner or driver is not disclosed
28	in connection with the retrieved data; and
29	(ii) The last four (4) digits of the vehicle
30	identification number are not disclosed; or
31	(3) To diagnose, service, or repair a motor vehicle.
32	(i) Notwithstanding any other provision of this section, the use of
33	data from a motor vehicle event data recorder shall not be permitted into
34	evidence in a civil or criminal matter pending before a court in the State of
35	Arkansas unless it is shown to be relevant and reliable pursuant to the

36 Arkansas Rules of Evidence.

1	(j)(l) If a motor vehicle is equipped with a motor vehicle event data
2	recorder that is capable of recording, storing, transmitting, or dispensing
3	information as described in this section and that capability is part of a
4	subscription service, that the information may be recorded, stored,
5	transmitted or dispensed shall be disclosed in the subscription agreement.
6	(2) Subsections (c), (d), (f), (g), and (h) shall not apply to
7	subscription services that meet the requirements of this subsection (j).
