- 27 advocate, the parties, and counsel with a copy of a review report no later
- 28 than seven (7) business days before every scheduled review hearing of each
- 29 juvenile who is in an out-of-home placement.
- 30 (2) The department shall present the report to the court at the
- 31 scheduled hearing, subject to evidentiary objections.
- 32 (g) The review report shall include a summary of the parties'
- 33 compliance with the case plan and court orders, including a description of
- 34 the services and assistance that the department has provided to the family.

36 SECTION 18. Arkansas Code § 9-27-341 is amended to read as follows:

- 1 9-27-341. Termination of parental rights.
- 2 (a)(1)(A) This section shall be a remedy available only to the
- 3 Department of Human Services or a court-appointed attorney ad litem.
- 4 (B) It shall not be available for private litigants or
- 5 other agencies.
- 6 (2) It shall be used only in cases in which the department is
- 7 attempting to clear a juvenile for permanent placement.

- 1 upon a finding by clear and convincing evidence: 2 (A) That it is in the best interest of the juvenile, 3 including consideration of the following factors: 4 The likelihood that the juvenile will be adopted (i) 5 if the termination petition is granted; and 6 The potential harm, specifically addressing the 7 effect on the health and safety of the child, caused by continuing contact 8 with returning the child to the custody of the parent, parents, or putative 9 parent or parents; and 10 (B) Of one (1) or more of the following grounds: 11 (i)(a) That a juvenile has been adjudicated by the 12 court to be dependent-neglected and has continued out of the custody of the parent for twelve (12) months and, despite a meaningful effort by the 13 14 department to rehabilitate the parent and correct the conditions that caused 15 removal, those conditions have not been remedied by the parent. 16 (b) It is not necessary that the twelve-month period referenced in subdivision (b)(3)(B)(i) of this section immediately 17 precede the filing of the petition for termination of parental rights or that 18 19 it be for twelve (12) consecutive months; (ii)(a) The juvenile has lived outside the home of 20 the parent for a period of twelve (12) months, and the parent has willfully 21 22 failed to provide significant material support in accordance with the 23 parent's means or to maintain meaningful contact with the juvenile. 24 (b) To find willful failure to maintain 25 meaningful contact, it must be shown that the parent was not prevented from 26 visiting or having contact with the juvenile by the juvenile's custodian or 27 any other person, taking into consideration the distance of the juvenile's 28 placement from the parent's home. 29 (c) Material support consists of either 30 financial contributions or food, shelter, clothing, or other necessities 31 where the contribution has been requested by the juvenile's custodian or 32 ordered by a court of competent jurisdiction.
- 33 (d) It is not necessary that the twelve-month 34 period referenced in subdivision (b)(3)(B)(ii) of this section immediately 35 precede the filing of the petition for termination of parental rights or that 36 it be for twelve (12) consecutive months;

1 (iii) The presumptive legal father is not the 2 biological father of the juvenile and the welfare of the juvenile can best be 3 served by terminating the parental rights of the presumptive legal father; 4 (iv) A parent has abandoned the juvenile; 5 (v) A parent has executed consent to termination of 6 parental rights or adoption of the juvenile, subject to the court's approval; 7 (vi)(a) The court has found the juvenile victim 8 dependent-neglected as a result of neglect or abuse that could endanger the 9 life of the child, sexual abuse, or sexual exploitation, any of which was 10 perpetrated by the juvenile's parent or parents. 11 (b) Such findings by the juvenile division of 12 circuit court shall constitute grounds for immediate termination of the parental rights of one (1) or both of the parents; 13 14 (vii)(a) That other factors or issues arose 15 subsequent to the filing of the original petition for dependency-neglect that 16 demonstrate that return of the juvenile to the custody of the parent is 17 contrary to the juvenile's health, safety, or welfare and that, despite the 18 offer of appropriate family services, the parent has manifested the 19 incapacity or indifference to remedy the subsequent issues or factors or rehabilitate the parent's circumstances that prevent return of the juvenile 20 21 to the custody of the parent. 22 (b) Provided, however, that the department 23 shall make reasonable accommodations in accordance with the Americans with 24 Disabilities Act, 42 U.S.C. § 1201 et seq., to parents with disabilities in 25 order to allow them meaningful access to reunification and family 26 preservation services. 27 (c) For purposes of subdivision (b)(3)(B)(vii) 28 of this section, the inability or incapacity to remedy or rehabilitate 29 includes, but is not limited to, mental illness, emotional illness, or mental 30 deficiencies; 31 (viii) The parent is sentenced in a criminal 32 proceeding for a period of time that would constitute a substantial period of 33 the juvenile's life and the conditions in subdivision (b)(3)(B)(i) or (ii) of 34 this section have also been established; and; or 35 (ix)(a) The parent is found by a court of competent 36 jurisdiction, including the juvenile division of circuit court, to:

34	(C) The juvenile has an appropriate place to live;

1	(E) The juvenile has a legal source of income, such as
2	employment or a trust fund;

16	(3) The juvenile has the right to enroll himself or herself in
17	school, college, or other educational programs;
18	(4) The juvenile has the right to obtain a driver's license
19	without consent of a parent or other adult so long as the juvenile complies
20	with the remaining requirements of the driver's license law;
21	(5) The juvenile's parents, legal guardians, or legal custodians
22	are no longer legally responsible for the juvenile;
23	(6) The juvenile may still be charged and prosecuted in juvenile
24	<pre>court with a delinquency;</pre>
25	(7) The juvenile may not marry without parental permission
26	pursuant to § 9-11-102;
27	(8) The juvenile is not relieved from compulsory school
28	attendance;
29	(9) The Department of Human Services is not relieved from the
30	responsibility of providing independent living services and funding for which
31	the juvenile is eligible upon request by the juvenile;
32	(10) Child support orders are not terminated but may cease upon
33	entry of an order from the court that issued the order of child support;
34	(11) Until the juvenile reaches the age of majority, the
35	juvenile remains eligible for federal programs and services as a juvenile;
36	(12) The juvenile is not permitted to obtain items prohibited

2	(13) The juvenile remains subject to state and federal laws
2	
3	enacted for the protection of persons under eighteen (18) years of age such
4	as the prohibition against a juvenile obtaining a tattoo; and
5	(14) No statute of limitations is affected.
