(A) No contract may be awarded nor 3 4 obligations otherwise incurred in relation to the project or projects 5 described herein in excess of the State Treasury funds actually available 6 therefor as provided by law. Provided, however, that institutions and 7 agencies listed herein shall have the authority to accept and use grants and 8 donations including Federal funds, and to use its unobligated cash income or 9 funds, or both available to it, for the purpose of supplementing the State 10 Treasury funds for financing the entire costs of the project or projects 11 enumerated herein. LEGISLATIVE INTENT. It is the intent of the General Assembly 22 23 that any funds disbursed under the authority of the appropriations contained 24 in this act shall be in compliance with the stated reasons for which this act 25 was adopted, as evidenced by the Agency Requests, Executive Recommendations 26 and Legislative Recommendations contained in the budget manuals prepared by 27 the Department of Finance and Administration, letters, or summarized oral 28 testimony in the official minutes of the Arkansas Legislative Council or 29 Joint Budget Committee which relate to its passage and adoption. 30 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 31 32 Assembly, that the Constitution of the State of Arkansas prohibits the 33 appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 2005 is essential to the operation of 34 35 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective 36
