13 TO ADOPT THE UNIFORM MONEY SERVICES ACT.

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 *SECTION 1. Arkansas Code Title 23 is amended to add an additional*
19 *chapter to read as follows:*

21 CHAPTER 55 -- UNIFORM MONEY SERVICES ACT

22
23 ARTICLE 1 -- GENERAL PROVISIONS

24
25 23-55-101. Short title.

26 This chapter may be cited as the Uniform Money Services Act.

27
28 23-55-102. Definitions.

29 In this chapter:

30 (1) "Applicant" means a person that files an application for a
31 license under this Act.

32 (2) "Authorized delegate" means a person a licensee designates
33 to provide money services on behalf of the licensee.

34 (3) "Bank" means an institution organized under federal or state
35 law which:



1 (A) accepts demand deposits or deposits that the depositor
2 may use for payment to third parties and engages in the business of making
3 commercial loans; or

4 (B) engages in credit card operations and maintains only
5 one office that accepts deposits, does not accept demand deposits or deposits
6 that the depositor may use for payments to third parties, does not accept a
7 savings or time deposit less than \$100,000, and does not engage in the
8 business of making commercial loans.

9 (4) "Commissioner" means the Securities Commissioner.

10 (5) "Control" means:

11 (A) Ownership of, or the power to vote, directly or
12 indirectly, at least 25 percent of a class of voting securities or voting
13 interests of a licensee or person in control of a licensee;

14 (B) power to elect a majority of executive officers,
15 managers, directors, trustees, or other persons exercising managerial
16 authority of a licensee or person in control of a licensee; or

17 (C) the power to exercise directly or indirectly, a
18 controlling influence over the management or policies of a licensee or person
19 in control of a licensee.

20 (6) "Currency exchange" means receipt of revenues from the
21 exchange of money of one government for money of another government.

22 (7) "Executive officer" means a president, chairperson of the
23 executive committee, chief financial officer, responsible individual, or
24 other individual who performs similar functions.

25 (8) "Licensee" means a person licensed under this Act.

26 (9) "Monetary value" means a medium of exchange, whether or not
27 redeemable in money.

28 (10) "Money" means a medium of exchange that is authorized or
29 adopted by the United States or a foreign government. The term includes a
30 monetary unit of account established by an intergovernmental organization or
31 by agreement between two or more governments.

32 (11) "Money services" means money transmission, check cashing,
33 or currency exchange.

34 (12) "Money transmission" means selling or issuing payment
35 instruments, stored value, or receiving money or monetary value for
36 transmission. The term does not include the provision solely of delivery,

1 online or telecommunications services, or network access.

2 (13) "Outstanding," with respect to a payment instrument, means
3 issued or sold by or for the licensee and reported as sold but not yet paid
4 by or for the licensee.

5 (14) "Payment instrument" means a check, draft, money order,
6 traveler's check, or other instrument for the transmission or payment of
7 money or monetary value, whether or not negotiable. The term does not include
8 a credit card voucher, letter of credit, or instrument that is redeemable by
9 the issuer in goods or services.

10 (15) "Person" means an individual, corporation, business trust,
11 estate, trust, partnership, limited liability company, association, joint
12 venture, government; governmental subdivision, agency or instrumentality;
13 public corporation; or any other legal or commercial entity.

14 (16) "Record" means information that is inscribed on a tangible
15 medium or that is stored in an electronic or other medium and is retrievable
16 in perceivable form.

17 (17) "Responsible individual" means an individual who is
18 employed by a licensee and has principal managerial authority over the
19 provision of money services by the licensee in this State.

20 (18) "State" means a State of the United States, the District of
21 Columbia, Puerto Rico, the United States Virgin Islands, or any territory or
22 insular possession subject to the jurisdiction of the United States.

23 (19) "Stored value" means monetary value that is evidenced by an
24 electronic record.

25 (20) "Unsafe or unsound practice" means a practice or conduct by
26 a person licensed to engage in money transmission or an authorized delegate
27 of such a person which creates the likelihood of material loss, insolvency,
28 or dissipation of the licensee's assets, or otherwise materially prejudices
29 the interests of its customers.

30
31 23-55-103. Exclusions.

32 This chapter does not apply to:

33 (1) the United States or a department, agency, or
34 instrumentality thereof;

35 (2) money transmission by the United States Postal Service or by
36 a contractor on behalf of the United States Postal Service;

1 (3) a state, county, city, or any other governmental agency or
2 governmental subdivision of a State;

3 (4) a bank, bank holding company, office of an international
4 banking corporation, branch of a foreign bank, corporation organized pursuant
5 to the Bank Service Corporation Act, 12 U.S.C. Section 1861-1867 (Supp. V
6 1999), or corporation organized under the Edge Act, 12 U.S.C. Section 611-633
7 (1994 & Supp. V 1999), under the laws of a State or the United States if it
8 does not issue, sell, or provide payment instruments or stored value through
9 an authorized delegate that is not such a person;

10 (5) electronic funds transfer of governmental benefits for a
11 federal, state, county, or governmental agency by a contractor on behalf of
12 the United States or a department, agency, or instrumentality thereof, or a
13 State or governmental subdivision, agency, or instrumentality thereof;

14 (6) a board of trade designated as a contract market under the
15 federal Commodity Exchange Act, 7 U.S.C. Section 1-25 (1994), or a person
16 that, in the ordinary course of business, provides clearance and settlement
17 services for a board of trade to the extent of its operation as or for such a
18 board;

19 (7) a registered futures commission merchant under the federal
20 commodities laws to the extent of its operation as such a merchant;

21 (8) a person that provides clearance or settlement services
22 pursuant to a registration as a clearing agency or an exemption from such
23 registration granted under the federal securities laws to the extent of its
24 operation as such a provider;

25 (9) an operator of a payment system to the extent that it
26 provides processing, clearing, or settlement services, between or among
27 persons excluded by this section, in connection with wire transfers, credit
28 card transactions, debit card transactions, stored-value transactions,
29 automated clearing house transfers; similar funds transfers; or

30 (10) a person registered as a securities broker-dealer under
31 federal or state securities laws to the extent of its operation as such a
32 broker-dealer; or

33 (11) a credit union regulated and insured by the National Credit
34 Union Association.

35
36 ARTICLE 2 -- MONEY TRANSMISSION LICENSES

1
2 23-55-201. License required.

3 (a) A person may not engage in the business of money transmission or
4 advertise, solicit, or hold itself out as providing money transmission unless
5 the person:

6 (1) is licensed under this subchapter or approved to engage in
7 money transmission under § 23-55-203;

8 (2) is an authorized delegate of a person licensed under this
9 subchapter; or

10 (3) is an authorized delegate of a person approved to engage in
11 money transmission under § 23-55-203.

12 (b) A license under this subchapter is not transferable or assignable.

13
14 23-55-202. Application for license.

15 (a) In this section, "material litigation" means litigation that
16 according to generally accepted accounting principles is significant to an
17 applicant's or a licensee's financial health and would be required to be
18 disclosed in the applicant's or licensee's annual audited financial
19 statements, report to shareholders, or similar records.

20 (b) A person applying for a license under this subchapter shall do so
21 in a form and in a medium prescribed by the commissioner. The application
22 must state or contain:

23 (1) the legal name and residential and business addresses of the
24 applicant and any fictitious or trade name used by the applicant in
25 conducting its business;

26 (2) a list of any criminal convictions of the applicant and any
27 material litigation in which the applicant has been involved in the 10-year
28 period next preceding the submission of the application;

29 (3) a description of any money services previously provided by
30 the applicant and the money services that the applicant seeks to provide in
31 this State;

32 (4) a list of the applicant's proposed authorized delegates and
33 the locations in this State where the applicant and its authorized delegates
34 propose to engage in money transmission or provide other money services;

35 (5) a list of other States in which the applicant is licensed to
36 engage in money transmission or provide other money services and any license

1 revocations, suspensions, or other disciplinary action taken against the
2 applicant in another State;

3 (6) information concerning any bankruptcy or receivership
4 proceedings affecting the licensee;

5 (7) a sample form of contract for authorized delegates, if
6 applicable, and a sample form of payment instrument or instrument upon which
7 stored value is recorded, if applicable;

8 (8) the name and address of any bank through which the
9 applicant's payment instruments and stored value will be paid;

10 (9) a description of the source of money and credit to be used
11 by the applicant to provide money services; and

12 (10) any other information the commissioner reasonably requires
13 with respect to the applicant.

14 (c) If an applicant is a corporation, limited liability company,
15 partnership, or other entity, the applicant shall also provide:

16 (1) the date of the applicant's incorporation or formation and
17 State or country of incorporation or formation;

18 (2) if applicable, a certificate of good standing from the State
19 or country in which the applicant is incorporated or formed;

20 (3) a brief description of the structure or organization of the
21 applicant, including any parent or subsidiary of the applicant, and whether
22 any parent or subsidiary is publicly traded;

23 (4) the legal name, any fictitious or trade name, all business
24 and residential addresses, and the employment, in the 10-year period next
25 preceding the submission of the application of each executive officer,
26 manager, director, or person that has control, of the applicant;

27 (5) a list of any criminal convictions and material litigation
28 in which any executive officer, manager, director, or person in control of,
29 the applicant has been involved in the 10-year period next preceding the
30 submission of the application;

31 (6) a copy of the applicant's audited financial statements for
32 the most recent fiscal year and, if available, for the two-year period next
33 preceding the submission of the application;

34 (7) a copy of the applicant's unconsolidated financial
35 statements for the current fiscal year, whether audited or not, and, if
36 available, for the two-year period next preceding the submission of the

1 application;

2 (8) if the applicant is publicly traded, a copy of the most
3 recent report filed with the United States Securities and Exchange Commission
4 under Section 13 of the federal Securities Exchange Act of 1934, 15 U.S.C.
5 Section 78m (1994 & Supp. V 1999);

6 (9) if the applicant is a wholly owned subsidiary of:

7 (A) a corporation publicly traded in the United States, a
8 copy of audited financial statements for the parent corporation for the most
9 recent fiscal year or a copy of the parent corporation's most recent report
10 filed under Section 13 of the federal Securities Exchange Act of 1934, 15
11 U.S.C. Section 78m (1994 & Supp. V 1999); or

12 (B) a corporation publicly traded outside the United
13 States, a copy of similar documentation filed with the regulator of the
14 parent corporation's domicile outside the United States;

15 (10) if the applicant has a registered agent in this State, the
16 name and address of the applicant's registered agent in this State; and

17 (11) any other information the commissioner reasonably requires
18 with respect to the applicant.

19 (d) A nonrefundable application fee of \$1,500 and a license fee of
20 \$750 must accompany an application for a license under this subchapter. The
21 license fee must be refunded if the application is denied.

22 (e) The commissioner may waive one or more requirements of subsections
23 (b) and (c) or permit an applicant to submit other information in lieu of the
24 required information.

25
26 23-55-203. Approval to engage in money transmission when licensed in
27 another state.

28 (a) A person that is licensed to engage in money transmission in at
29 least one other state, with the approval of the commissioner and in
30 accordance with this section, may engage in money transmission and currency
31 exchange in this state without being licensed pursuant to § 23-55-202 if:

32 (1) the state in which the person is licensed has enacted the
33 Uniform Money Services Act or the commissioner determines that the money
34 transmission laws of that state are substantially similar to those imposed by
35 the law of this state;

36 (2) the person submits to, and in the form required by, the

1 commissioner:

2 (A) in a record, an application for approval to engage in
3 money transmission and currency exchange in this state without being licensed
4 pursuant to § 23-55-202;

5 (B) a nonrefundable fee of \$1,000; and

6 (C) a certification of license history in the other state.

7 (b) When an application for approval under this section is complete,
8 the commissioner shall promptly notify the applicant, in a record, of the
9 date on which the request was determined to be complete and:

10 (1) the commissioner shall approve or deny the request within 120
11 days after that date; or

12 (2) if the request is not approved or denied within 120 days
13 after that date:

14 (A) the request is approved; and

15 (B) the approval takes effect as of the first business day
16 after expiration of the 120-day period.

17 (c) A person that engages in money transmission and currency exchange
18 in this state pursuant to this section shall comply with the requirements of,
19 and is subject to the sanctions under, Articles 6, 7, and 8, § 23-55-601 et
20 seq., § 23-55-701 et seq., and § 23-55-801 et seq., as if the person were
21 licensed pursuant to § 23-55-202.

22
23 23-55-204. Security.

24 (a) Except as otherwise provided in subsection (b), a surety bond,
25 letter of credit, or other similar security acceptable to the commissioner in
26 the amount of \$50,000 plus \$10,000 per location, not exceeding a total
27 addition of \$250,000, must accompany an application for a license.

28 (b) Security must be in a form satisfactory to the commissioner and
29 payable to the State for the benefit of any claimant against the licensee to
30 secure the faithful performance of the obligations of the licensee with
31 respect to money transmission.

32 (c) The aggregate liability on a surety bond may not exceed the
33 principal sum of the bond. A claimant against a licensee may maintain an
34 action on the bond, or the commissioner may maintain an action on behalf of
35 the claimant.

36 (d) A surety bond must cover claims for so long as the commissioner

1 specifies, but for at least five years after the licensee ceases to provide
2 money services in this State. However, the commissioner may permit the amount
3 of security to be reduced or eliminated before the expiration of that time to
4 the extent the amount of the licensee's payment instruments or stored-value
5 obligations outstanding in this State is reduced. The commissioner may permit
6 a licensee to substitute another form of security acceptable to the
7 commissioner for the security effective at the time the licensee ceases to
8 provide money services in this State.

9 (e) In lieu of the security prescribed in this section, an applicant
10 for a license or a licensee may provide security in a form prescribed by the
11 commissioner.

12 (f) The commissioner may increase the amount of security required to a
13 maximum of \$1,000,000 if the financial condition of a licensee so requires,
14 as evidenced by reduction of net worth, financial losses, or other relevant
15 criteria.

16
17 23-55-205. Issuance of license.

18 (a) When an application is filed under this subchapter, the
19 commissioner shall investigate the applicant's financial condition and
20 responsibility, financial and business experience, character, and general
21 fitness. The commissioner may conduct an on-site investigation of the
22 applicant, the reasonable cost of which the applicant must pay. The
23 commissioner shall issue a license to an applicant under this subchapter if
24 the commissioner finds that all of the following conditions have been
25 fulfilled:

26 (1) the applicant has complied with §§ 23-55-202, 23-55-204, and
27 23-55-207; and

28 (2) the financial condition and responsibility, financial and
29 business experience, competence, character, and general fitness of the
30 applicant; and the competence, experience, character, and general fitness of
31 the executive officers, managers, directors, and persons in control of, the
32 applicant indicate that it is in the interest of the public to permit the
33 applicant to engage in money transmission;

34 (b) When an application for an original license under this subchapter
35 is complete, the commissioner shall promptly notify the applicant in a record
36 of the date on which the application was determined to be complete and:

1 (1) the commissioner shall approve or deny the application
2 within 120 days after that date; or

3 (2) if the application is not approved or denied within 120 days
4 after that date:

5 (A) the application is deemed approved; and

6 (B) the commissioner shall issue the license under this
7 subchapter, to take effect as of the first business day after expiration of
8 the 120-day period.

9 (c) The commissioner may for good cause extend the application period.

10 (d) An applicant whose application is denied by the commissioner under
11 this subchapter may appeal, within 30 days after receipt of the notice of the
12 denial, from the denial and request a hearing.

13
14 23-55-206. Renewal of license.

15 (a) A licensee under this subchapter shall pay an annual renewal fee
16 of \$750 no later than 30 days before the anniversary of the issuance of the
17 license or, if the last day is not a business day, on the next business day.

18 (b) A licensee under this subchapter shall submit a renewal report
19 with the renewal fee, in a form and in a medium prescribed by the
20 commissioner. The renewal report must state or contain:

21 (1) a copy of the licensee's most recent audited annual
22 financial statement or, if the licensee is a wholly owned subsidiary of
23 another corporation, the most recent audited consolidated annual financial
24 statement of the parent corporation or the licensee's most recent audited
25 consolidated annual financial statement;

26 (2) the number and monetary amount of payment instruments and
27 stored-value sold by the licensee in this State which have not been included
28 in a renewal report, and the monetary amount of payment instruments and
29 stored value currently outstanding;

30 (3) a description of each material change in information
31 submitted by the licensee in its original license application which has not
32 been reported to the commissioner on any required report;

33 (4) a list of the licensee's permissible investments and a
34 certification that the licensee continues to maintain permissible investments
35 according to the requirements set forth in §§ 23-55-701 and 23-55-702;

36 (5) proof that the licensee continues to maintain adequate

1 security as required by § 23-55-204; and

2 (6) a list of the locations in this State where the licensee or
3 an authorized delegate of the licensee engages in money transmission or
4 provides other money services.

5 (c) If a licensee does not file a renewal report or pay its renewal
6 fee by the renewal date or any extension of time granted by the commissioner,
7 the commissioner shall send the licensee a notice of suspension. Unless the
8 licensee files the report and pays the renewal fee before expiration of 10
9 days after the notice is sent, the licensee's license is suspended 10 days
10 after the commissioner sends the notice of suspension. The suspension must be
11 lifted if, within 20 days after its license is suspended, the licensee:

12 (1) files the report and pays the renewal fee; and

13 (2) pays \$100 for each day after suspension that the
14 commissioner did not receive the renewal report and the renewal fee.

15 (d) The commissioner for good cause may grant an extension of the
16 renewal date.

17
18 23-55-207. Net worth.

19 A licensee under this subchapter shall maintain a net worth of at least
20 \$250,000 determined in accordance with generally accepted accounting
21 principles.

22
23 ARTICLE 3 -- [Reserved.]

24
25 ARTICLE 4 -- CURRENCY EXCHANGE LICENSES

26
27 23-55-401. License required.

28 (a) A person may not engage in currency exchange or advertise, solicit,
29 or hold itself out as providing currency exchange for which the person
30 receives revenues equal or greater than five percent of total revenues unless
31 the person:

32 (1) is licensed under this subchapter;

33 (2) is licensed for money transmission under Article 2, § 23-55-
34 201 et seq., or approved to engage in money transmission under § 23-55-203;

35 (3) is an authorized delegate of a person licensed under Article
36 2, § 23-55-201 et seq.; or

1 (4) is an authorized delegate of a person approved to engage in
2 money transmission under § 23-55-203.

3 (b) A license under this subchapter is not transferable or assignable.

4
5 23-55-402. Application for license.

6 (a) A person applying for a license under this subchapter shall do so
7 in a form and in a medium prescribed by the commissioner. The application
8 must state or contain:

9 (1) the legal name and residential and business addresses of the
10 applicant, if the applicant is an individual or, if the applicant is not an
11 individual, the name of each partner, executive officer, manager, and
12 director;

13 (2) the location of the principal office of the applicant;

14 (3) complete addresses of other locations in this State where
15 the applicant proposes to engage in currency exchange or check cashing,
16 including all limited stations and mobile locations;

17 (4) a description of the source of money and credit to be used
18 by the applicant to engage in check cashing and currency exchange; and

19 (5) other information the commissioner reasonably requires with
20 respect to the applicant, but not more than the commissioner may require
21 under subchapter 2.

22 (b) A nonrefundable application fee of \$1,500 and a license fee of
23 \$750 must accompany an application for a license under this subchapter. The
24 license fee must be refunded if the application is denied.

25
26 23-55-403. Issuance of license.

27 (a) When an application under this subchapter, the commissioner shall
28 investigate the applicant's financial condition and responsibility, financial
29 and business experience, character, and general fitness. The commissioner may
30 conduct an on-site investigation of the applicant, the reasonable cost of
31 which the applicant must pay. The commissioner shall issue a license to an
32 applicant under this subchapter if the commissioner finds that all of the
33 following conditions have been fulfilled:

34 (1) the applicant has complied with § 23-55-402; and

35 (2) the financial condition and responsibility, financial and
36 business experience, competence, character, and general fitness of the

1 applicant; and the competence, experience, character, and general fitness of
2 the executive officers, managers, directors, and persons in control of, the
3 applicant indicate that it is in the interest of the public to permit the
4 applicant to engage in currency exchange.

5 (b) When an application for an original license under this subchapter
6 is complete, the commissioner shall promptly notify the applicant in a record
7 of the date on which the application was determined to be complete and:

8 (1) the commissioner shall approve or deny the application
9 within 120 days after that date; or

10 (2) if the application is not approved or denied within 120 days
11 after that date:

12 (A) the application is deemed approved; and

13 (B) the commissioner shall issue the license under this
14 subchapter, to take effect as of the first business day after expiration of
15 the period.

16 (c) The commissioner may for good cause extend the application period.

17 (d) An applicant whose application is denied a license by the
18 commissioner under this subchapter may appeal, within 30 days after receipt
19 of the notice of the denial, from the denial and request a hearing.

20
21 23-55-404. Renewal of License.

22 (a) A licensee under this subchapter shall pay a biennial renewal fee
23 of \$750 no later than 30 days before each biennial anniversary of the
24 issuance of the license or, if the last day is not a business day, on the
25 next business day.

26 (b) A licensee under this subchapter shall submit a renewal report
27 with the renewal fee, in a form and in a medium prescribed by the
28 commissioner. The renewal report must state or contain:

29 (1) a description of each material change in information
30 submitted by the licensee in its original license application that has not
31 been reported to the commissioner on any required report; and

32 (2) a list of the locations in this State where the licensee or
33 an authorized delegate of the licensee engages in currency exchange or check
34 cashing, including limited stations and mobile locations.

35 (c) If a licensee does not file a renewal report and pay its renewal
36 fee by the renewal date or any extension of time granted by the commissioner,

1 the commissioner shall send the licensee a notice of suspension. Unless the
2 licensee files the report and pays the renewal fee before expiration of 10
3 days after the notice is sent, the licensee's license is suspended 10 days
4 after the commissioner sends the notice of suspension.

5 (d) The commissioner for good cause may grant an extension of the
6 renewal date.

7
8 ARTICLE 5--AUTHORIZED DELEGATES

9
10 23-55-501. Relationship between licensee and authorized delegate.

11 (a) In this section, "remit" means to make direct payments of money to
12 a licensee or its representative authorized to receive money or to deposit
13 money in a bank in an account specified by the licensee.

14 (b) A contract between a licensee and an authorized delegate must
15 require the authorized delegate to operate in full compliance with this
16 chapter. The licensee shall furnish in a record to each authorized delegate
17 policies and procedures sufficient for compliance with this chapter.

18 (c) An authorized delegate shall remit all money owing to the licensee
19 in accordance with the terms of the contract between the licensee and the
20 authorized delegate.

21 (d) If a license is suspended or revoked or a licensee does not renew
22 its license, the commissioner shall notify all authorized delegates of the
23 licensee whose names are in a record filed with the commissioner of the
24 suspension, revocation, or non-renewal. After notice is sent or publication
25 is made, an authorized delegate shall immediately cease to provide money
26 services as a delegate of the licensee.

27 (e) An authorized delegate may not provide money services outside the
28 scope of activity permissible under the contract between the authorized
29 delegate and the licensee, except activity in which the authorized delegate
30 is authorized to engage under subchapter 2 or 4. An authorized delegate of a
31 licensee holds in trust for the benefit of the licensee all money net of fees
32 received from money transmission.

33 (f) An authorized delegate may not use a subdelegate to conduct money
34 services on behalf of a licensee.

35
36 23-55-502. Unauthorized activities.

1 A person may not provide money services on behalf of a person not
2 licensed under this chapter. A person that engages in that activity provides
3 money services to the same extent as if the person were a licensee.

4
5 ARTICLE 6--EXAMINATIONS – REPORTS – RECORDS

6
7 23-55-601. Authority to conduct examinations.

8 (a) The commissioner may conduct an annual examination of a licensee
9 or of any of its authorized delegates upon 45 days' notice in a record to the
10 licensee.

11 (b) The commissioner may examine a licensee or its authorized
12 delegate, at any time, without notice, if the commissioner has reason to
13 believe that the licensee or authorized delegate is engaging in an unsafe or
14 unsound practice or has violated or is violating this chapter or a rule
15 adopted or an order issued under this chapter.

16 (c) If the commissioner concludes that an on-site examination is
17 necessary under subsection (a), the licensee shall pay the reasonable cost of
18 the examination.

19 (d) Information obtained during an examination under this chapter may
20 be disclosed only as provided in § 23-55-607.

21
22 23-55-602. Cooperation.

23 The commissioner may consult and cooperate with other state money
24 services regulators in enforcing and administering this act. They may jointly
25 pursue examinations and take other official action that they are otherwise
26 empowered to take.

27
28 23-55-603. Reports.

29 (a) A licensee shall file with the commissioner within 15 business days
30 any material changes in information provided in a licensee's application as
31 prescribed by the commissioner.

32 (b) A licensee shall file with the commissioner within 45 days after
33 the end of each fiscal quarter a current list of all authorized delegates,
34 and locations in this State where the licensee or an authorized delegate of
35 the licensee provides money services, including limited stations and mobile
36 locations. The licensee shall state the name and street address of each

1 location and authorized delegate.

2 (c) A licensee shall file a report with the commissioner within three
3 business days after the licensee has reason to know of the occurrence of any
4 of the following events:

5 (1) the filing of a petition by or against the licensee under the
6 United States Bankruptcy Code, 11 U.S.C. Section 101-110 (1994 & Supp. V.
7 1999), for bankruptcy or reorganization;

8 (2) the filing of a petition by or against the licensee for
9 receivership, the commencement of any other judicial or administrative
10 proceeding for its dissolution or reorganization, or the making of a general
11 assignment for the benefit of its creditors;

12 (3) the commencement of a proceeding to revoke or suspend its
13 license in a State or country in which the licensee engages in business or is
14 licensed;

15 (4) the cancellation or other impairment of the licensee's bond
16 or other security;

17 (5) a charge or conviction of the licensee or of an executive
18 officer, manager, director, or person in control, of the licensee for a
19 felony; or

20 (6) a charge or conviction of an authorized delegate for a
21 felony.

22
23 23-55-604. Change of control.

24 (a) A licensee shall:

25 (1) give the commissioner notice in a record of a proposed
26 change of control within 15 days after learning of the proposed change of
27 control;

28 (2) request approval of the acquisition; and

29 (3) submit a nonrefundable fee of \$1,000 with the notice.

30 (b) After review of a request for approval under subsection (a), the
31 commissioner may require the licensee to provide additional information
32 concerning the proposed persons in control of the licensee. The additional
33 information must be limited to the same types required of the licensee or
34 persons in control of the licensee as part of its original license or renewal
35 application.

36 (c) The commissioner shall approve a request for change of control

1 under subsection (a) if, after investigation, the commissioner determines
2 that the person or group of persons requesting approval has the competence,
3 experience, character, and general fitness to operate the licensee or person
4 in control of the licensee in a lawful and proper manner and that the public
5 interest will not be jeopardized by the change of control.

6 (d) When an application for a change of control under this subchapter
7 is complete, the commissioner shall notify the licensee in a record of the
8 date on which the request was determined to be complete and:

9 (1) the commissioner shall approve or deny the request within
10 120 days after that date; or

11 (2) if the request is not approved or denied within 120 days
12 after that date:

13 (A) the request is deemed approved; and

14 (B) the commissioner shall permit the change of control
15 under this section, to take effect as of the first business day after
16 expiration of the period.

17 (e) The commissioner, by rule of order, may exempt a person from any
18 of the requirements of subsection (a)(2) and (3) if it is in the public
19 interest to do so.

20 (f) Subsection (a) does not apply to a public offering of securities.

21 (g) Before filing a request for approval to acquire control of a
22 licensee or person in control of a licensee, a person may request in a record
23 a determination from the commissioner as to whether the person would be
24 considered a person in control of a licensee upon consummation of a proposed
25 transaction. If the commissioner determines that the person would not be a
26 person in control of a licensee, the commissioner shall enter an order to
27 that effect and the proposed person and transaction is not subject to the
28 requirements of subsections (a) through (c).

29
30 23-55-605. Records.

31 (a) A licensee shall maintain the following records for determining
32 its compliance with this Act for at least three years:

33 (1) a record of each payment instrument or stored-value
34 obligation sold;

35 (2) a general ledger posted at least monthly containing all
36 asset, liability, capital, income, and expense accounts;

1 (3) bank statements and bank reconciliation records;

2 (4) records of outstanding payment instruments and stored-value
3 obligations;

4 (5) records of each payment instrument and stored-value
5 obligation paid within the three-year period;

6 (6) a list of the last known names and addresses of all of the
7 licensee's authorized delegates; and

8 (7) any other records the commissioner reasonably requires by
9 rule.

10 (b) The items specified in subsection (a) may be maintained in any
11 form of record.

12 (c) Records may be maintained outside this State if they are made
13 accessible to the commissioner on seven business-days' notice that is sent in
14 a record.

15 (d) All records maintained by the licensee as required in subsections
16 (a) through (c) are open to inspection by the commissioner pursuant to § 23-
17 55-601.

18
19 23-55-606. Money laundering reports.

20 (a) A licensee and an authorized delegate shall file with the
21 commissioner all reports required by federal currency reporting, record
22 keeping, and suspicious transaction reporting requirements as set forth in 31
23 U.S.C. Section 5311 (1994), 31 C.F.R. Section 103 (2000) and other federal
24 and state laws pertaining to money laundering.

25 (b) The timely filing of a complete and accurate report required under
26 subsection (a) with the appropriate federal agency is compliance with the
27 requirements of subsection (a), unless the commissioner notifies the licensee
28 that reports of this type are not being regularly and comprehensively
29 transmitted by the federal agency to the commissioner.

30
31 23-55-607. Confidentiality.

32 (a)(1) Unless otherwise specified in this section, all information
33 filed with the Securities Commissioner shall be available for public
34 inspection under rules promulgated by the commissioner consistent with state
35 and federal law governing the disclosure of public information.

36 (b) Except for reasonably segregable portions of information and

1 records that by law would routinely be made available to a party other than
2 an agency in litigation with the commissioner, the commissioner shall not
3 publish or make available:

4 (1) Information contained in reports, summaries, analyses,
5 letters, or memoranda arising out of, in anticipation of, or in connection
6 with an investigation, examination, or inspection of the books and records of
7 any person;

8 (2) Interagency or intra-agency memoranda or letters, including
9 without limitation:

10 (A) Records that reflect discussions between or
11 consideration by the commissioner or members of his or her staff, or both, of
12 any action taken or proposed to be taken by the commissioner or by any
13 members of his or her staff; and

14 (B) Reports, summaries, analyses, conclusions, or any
15 other work product of the commissioner or of attorneys, accountants,
16 analysts, or other members of the commissioner's staff, prepared in the
17 course of an:

18 (i) Inspection of the books or records of a person
19 whose affairs are regulated by the commissioner; or

20 (ii) Examination, investigation, or litigation
21 conducted by or on behalf of the commissioner;

22 (3) Personnel files, medical files, and similar files if
23 disclosure would constitute a clearly unwarranted invasion of personal
24 privacy, including without limitation:

25 (A) Information concerning all employees of the State
26 Securities Department and all persons subject to regulation by the
27 department; and

28 (B) Personal information reported to the commissioner
29 under the department's rules concerning registration about employees of
30 applicants, licensees, or their agents;

31 (4)(A) Investigatory records compiled for law enforcement
32 purposes to the extent that production of the records would:

33 (i) Interfere with enforcement proceedings;

34 (ii) Deprive a person of a right to a fair trial or
35 an impartial adjudication; or

36 (iii) Disclose the identity of a confidential

1 source.

2 (B) The commissioner may also withhold investigatory
3 records that would:

4 (i) Constitute an unwarranted invasion of personal
5 privacy;

6 (ii) Disclose investigative techniques and
7 procedures; or

8 (iii) Endanger the life or physical safety of law
9 enforcement personnel.

10 (C) As used in this section, "investigatory records"
11 includes:

12 (i) All documents, records, transcripts,
13 correspondence, and related memoranda and work products concerning
14 examinations and other investigations and related litigation as authorized by
15 law that pertain to or may disclose the possible violation by any person of
16 any provision of the statutes or rules administered by the commissioner; and

17 (ii) All written communications from or to any
18 person confidentially complaining or otherwise furnishing information about a
19 possible violation, as well as all correspondence and memoranda in connection
20 with the confidential complaint or information;

21 (5) Information contained in or related to examinations,
22 operating reports, or condition reports prepared by, on behalf of, or for the
23 use of any agency responsible for the regulation or supervision of financial
24 institutions, check issuers, money transmitters, money services providers, or
25 money service businesses;

26 (6)(A) Financial records of any applicant, licensee, or the
27 agent of an applicant or licensee obtained during or as a result of an
28 examination by the commissioner.

29 (B) However, when a record under this subchapter is
30 required to be filed with the commissioner as part of an application for
31 license, annual renewal, or otherwise, the record, including financial
32 statements prepared by certified public accountants, shall be public
33 information unless sections of the information are bound separately and are
34 marked "confidential" by the applicant, licensee, or agent upon filing.

35 (C) Information under subdivision (b)(6)(B) of this
36 section bound separately and marked "confidential" shall be deemed nonpublic

1 until ten (10) days after the commissioner has given the applicant, licensee,
2 or agent notice that an order will be entered deeming the material public
3 information.

4 (D) An applicant, licensee, or agent may seek an
5 injunction from the Pulaski County Circuit Court ordering the commissioner to
6 withhold the information as nonpublic pending a final order from a court of
7 competent jurisdiction if the order of the commissioner under subdivision
8 (b)(6)(C) of this section is appealed under applicable law;

9 (7) Trade secrets obtained from any person; or

10 (8) Any other records that are required to be closed to the
11 public and are not deemed open to public inspection under other law.

12 (c) The commissioner may disclose information not otherwise subject to
13 disclosure under subsection (a) to representatives of state or federal
14 agencies who promise in a record that they will maintain the confidentiality
15 of the information; or the commissioner finds that the release is reasonably
16 necessary for the protection of the public and in the interests of justice,
17 and the licensee has been given previous notice by the commissioner of its
18 intent to release the information.

19 (d) This section does not prohibit the commissioner from disclosing to
20 the public a list of persons licensed under this chapter or the aggregated
21 financial data concerning those licensees.

22

23 ARTICLE 7--PERMISSIBLE INVESTMENTS

24

25 23-55-701. Maintenance of permissible investments.

26 (a) A licensee shall maintain at all times permissible investments that
27 have a market value computed in accordance with generally accepted accounting
28 principles of not less than he aggregate amount of all of its outstanding
29 payment instruments and stored value obligations issued or sold in all states
30 and money transmitted from all states by the licensee.

31 (b) The commissioner, with respect to any licensees, may limit the
32 extent to which a type of investment within a class of permissible
33 investments may be considered a permissible investment, except for money and
34 certificates of deposit issued by a bank. The commissioner by rule may
35 prescribe or by order allow other types of investments that the commissioner
36 determines to have a safety substantially equivalent to other permissible

1 investments.

2 (c) Permissible investments, even if commingled with other assets of
3 the licensee, are held in trust for the benefit of the purchasers and holders
4 of the licensee's outstanding payment instruments and stored value
5 obligations in the event of bankruptcy or receivership of the licensee.

6
7 23-55-702. Types of permissible investments.

8 (a) Except to the extent otherwise limited by the commissioner
9 pursuant to Section 701, the following investments are permissible under §
10 23-55-701:

11 (1) cash, a certificate of deposit, or senior debt obligation of
12 an insured depository institution, as defined in Section 3 of the Federal
13 Deposit Insurance Act, 12 U.S.C. Section 1813 (1994 & Supp. V. 1999);

14 (2) banker's acceptance or bill of exchange that is eligible for
15 purchase upon endorsement by a member bank of the Federal Reserve System and
16 is eligible for purchase by a Federal Reserve Bank;

17 (3) an investment bearing a rating of one of the three highest
18 grades as defined by a nationally recognized organization that rates
19 securities;

20 (4) an investment security that is an obligation of the United
21 States or a department, agency, or instrumentality thereof; an investment in
22 an obligation that is guaranteed fully as to principal and interest by the
23 United States; or an investment in an obligation of a State or a governmental
24 subdivision, agency, or instrumentality thereof;

25 (5) receivables that are payable to a licensee from its
26 authorized delegates, in the ordinary course of business, pursuant to
27 contracts which are not past due or doubtful of collection if the aggregate
28 amount of receivables under this paragraph does not exceed 20 percent of the
29 total permissible investments of a licensee and the licensee does not hold at
30 one time receivables under this paragraph in any one person aggregating more
31 than 10 percent of the licensee's total permissible investments; and

32 (6) a share or a certificate issued by an open-end management
33 investment company that is registered with the United States Securities and
34 Exchange Commission under the Investment Companies Act of 1940, 15 U.S.C.
35 Section 80a-1-64 (1994 & Supp. V 1999), and whose portfolio is restricted by
36 the management company's investment policy to investments specified in

1 paragraphs (1) through (4).

2 (b) The following investments are permissible under § 23-55-701, but
3 only to the extent specified:

4 (1) an interest-bearing bill, note, bond, or debenture of a
5 person whose equity shares are traded on a national securities exchange or on
6 a national over-the-counter market, if the aggregate of investments under
7 this paragraph does not exceed 20 percent of the total permissible
8 investments of a licensee and the licensee does not at one time hold
9 investments under this paragraph in any one person aggregating more than 10
10 percent of the licensee's total permissible investments;

11 (2) a share of a person traded on a national securities exchange
12 or a national over-the-counter market or a share or a certificate issued by
13 an open-end management investment company that is registered with the United
14 States Securities and Exchange Commission under the Investment Companies Act
15 of 1940, 15 U.S.C. Section 80a-1-64 (1994 & Supp. V 1999), and whose
16 portfolio is restricted by the management company's investment policy to
17 shares of a person traded on a national securities exchange or a national
18 over-the-counter market, if the aggregate of investments under this paragraph
19 does not exceed 20 percent of the total permissible investments of a licensee
20 and the licensee does not at one time hold investments in any one person
21 aggregating more than 10 percent of the licensee's total permissible
22 investments;

23 (3) a demand-borrowing agreement made to a corporation or a
24 subsidiary of a corporation whose securities are traded on a national
25 securities exchange if the aggregate of the amount of principal and interest
26 outstanding under demand-borrowing agreements under this paragraph does not
27 exceed 20 percent of the total permissible investments of a licensee and the
28 licensee does not at one time hold principal and interest outstanding under
29 demand-borrowing agreements under this paragraph with any one person
30 aggregating more than 10 percent of the licensee's total permissible
31 investments; and

32 (4) any other investment the commissioner designates, to the
33 extent specified by the commissioner.

34 (c) The aggregate of investments under subsection (b) may not exceed
35 50 percent of the total permissible investments of a licensee calculated in
36 accordance with § 23-55-701.

1
2 ARTICLE 8--ENFORCEMENT

3
4 23-55-801. Suspension and revocation.

5 (a) The commissioner may suspend or revoke a license or order a
6 licensee to revoke the designation of an authorized delegate if:

7 (1) the licensee violates this chapter or a rule adopted or an
8 order issued under this Act;

9 (2) the licensee does not cooperate with an examination or
10 investigation by the commissioner;

11 (3) the licensee engages in fraud, intentional
12 misrepresentation, or gross negligence;

13 (4) an authorized delegate is convicted of a violation of a
14 state or federal anti-money laundering statute, or violates a rule adopted or
15 an order issued under this chapter, as a result of the licensee's willful
16 misconduct or willful blindness;

17 (5) the competence, experience, character, or general fitness of
18 the licensee, authorized delegate, person in control of a licensee, or
19 responsible person of the licensee or authorized delegate indicates that it
20 is not in the public interest to permit the person to provide money services;

21 (6) the licensee engages in an unsafe or unsound practice;

22 (7) the licensee is insolvent, suspends payment of its
23 obligations, or makes a general assignment for the benefit of its creditors;
24 or

25 (8) the licensee does not remove an authorized delegate after
26 the commissioner issues and serves upon the licensee a final order including
27 a finding that the authorized delegate has violated this chapter.

28 (b) In determining whether a licensee is engaging in an unsafe or
29 unsound practice, the commissioner may consider the size and condition of the
30 licensee's money transmission, the magnitude of the loss, the gravity of the
31 violation of this Act, and the previous conduct of the person involved.

32
33 23-55-802. Suspension and revocation of authorized delegates.

34 (a) The commissioner may issue an order suspending or revoking the
35 designation of an authorized delegate, if the commissioner finds that:

36 (1) the authorized delegate violated this chapter or a rule

1 adopted or an order issued under this chapter;

2 (2) the authorized delegate did not cooperate with an
3 examination or investigation by the commissioner;

4 (3) the authorized delegate engaged in fraud, intentional
5 misrepresentation, or gross negligence;

6 (4) the authorized delegate is convicted of a violation of a
7 state or federal anti-money laundering statute;

8 (5) the competence, experience, character, or general fitness of
9 the authorized delegate or a person in control of the authorized delegate
10 indicates that it is not in the public interest to permit the authorized
11 delegate to provide money services; or

12 (6) the authorized delegate is engaging in an unsafe or unsound
13 practice.

14 (b) In determining whether an authorized delegate is engaging in an
15 unsafe or unsound practice, the commissioner may consider the size and
16 condition of the authorized delegate's provision of money services, the
17 magnitude of the loss, the gravity of the violation of this chapter or a rule
18 adopted or order issued under this chapter, and the previous conduct of the
19 authorized delegate.

20 (c) An authorized delegate may apply for relief from a suspension or
21 revocation of designation as an authorized delegate according to procedures
22 prescribed by the commissioner.

23
24 23-55-803. Orders to cease and desist.

25 (a) If the commissioner determines that a violation of this chapter or
26 of a rule adopted or an order issued under this chapter by a licensee or
27 authorized delegate is likely to cause immediate and irreparable harm to the
28 licensee, its customers, or the public as a result of the violation, or cause
29 insolvency or significant dissipation of assets of the licensee, the
30 commissioner may issue an order requiring the licensee or authorized delegate
31 to cease and desist from the violation. The order becomes effective upon
32 service of it upon the licensee or authorized delegate.

33 (b) The commissioner may issue an order against a licensee to cease
34 and desist from providing money services through an authorized delegate that
35 is the subject of a separate order by the commissioner.

36 (c) An order to cease and desist remains effective and enforceable

1 pending the completion of an administrative proceeding pursuant to § 23-55-
2 801 or § 23-55-802.

3
4 23-55-804. Consent orders.

5 The commissioner may enter into a consent order at any time with a
6 person to resolve a matter arising under this chapter or a rule adopted or
7 order issued under this chapter. A consent order must be signed by the person
8 to whom it is issued or by the person's authorized representative, and must
9 indicate agreement with the terms contained in the order. A consent order may
10 provide that it does not constitute an admission by a person that this
11 chapter or a rule adopted or an order issued under this chapter has been
12 violated.

13
14 23-55-805. Civil penalties.

15 The commissioner may assess a civil penalty against a person that
16 violates this chapter or a rule adopted or an order issued under this chapter
17 in an amount not to exceed \$1,000 per day for each day the violation is
18 outstanding, plus this State's costs and expenses for the investigation and
19 prosecution of the matter, including reasonable attorney's fees.

20
21 23-55-806. Criminal penalties.

22 (a) A person that intentionally makes a false statement,
23 misrepresentation, or false certification in a record filed or required to be
24 maintained under this chapter, that intentionally makes a false entry or
25 omits a material entry in such a record, or violates any rule promulgated or
26 order issued hereunder is guilty of a Class B felony.

27 (b) A person that knowingly engages in an activity for which a license
28 is required under this chapter without being licensed under this chapter and
29 who receives more than \$500 in compensation within a 30-day period from this
30 activity is guilty of a Class B felony.

31 (c) A person that knowingly engages in an activity for which a license
32 is required under this chapter without being licensed under this chapter and
33 who receives no more than \$500 in compensation within a 30-day period from
34 this activity is guilty of a Class A misdemeanor.

35
36 23-55-807. Unlicensed persons.

1 (a) If the commissioner has reason to believe that a person has
2 violated or is violating § 23-55-201 or § 23-55-401 the commissioner may
3 issue an order to show cause why an order to cease and desist should not
4 issue requiring that the person cease and desist from the violation of § 23-
5 55-201 or § 23-55-401.

6 (b) In an emergency, the commissioner may petition the Pulaski County
7 Circuit Court for the issuance of a temporary restraining order ex parte
8 pursuant to the rules of civil procedure.

9 (c) An order to cease and desist becomes effective upon service of it
10 upon the person.

11 (d) An order to cease and desist remains effective and enforceable
12 pending the completion of an administrative proceeding pursuant to §§ 23-55-
13 901 and 23-55-902.

14
15 23-55-808. Receivership.

16 (a)(1) Whenever a licensee has refused or is unable to pay its
17 obligations generally as they become due or whenever it appears to the
18 commissioner that a licensee is in an unsafe or unsound condition, the
19 commissioner, or the Attorney General representing the commissioner, may
20 apply to the Pulaski County Circuit Court or to the circuit court of
21 any county in which the licensee is located for the appointment of a receiver
22 for the licensee. The court may require the receiver to post a bond in such
23 amount as may appear necessary to protect claimants of the licensee.

24 (2) The receiver, subject to the approval of the court, shall
25 take possession of the books, records, and assets of the licensee and shall
26 take such action with respect to employees, agents, or representatives of the
27 licensee or such other action as may be necessary to conserve the assets of
28 the licensee or ensure payment of instruments issued by the licensee pending
29 further disposition of its business as provided by law. The receiver shall
30 sue and defend, compromise, and settle all claims involving the licensee and
31 exercise such powers and duties as may be necessary and consistent with the
32 laws of this state applicable to the appointment of receivers.

33 (3) The receiver, from time to time, but in no event less
34 frequently than once each calendar quarter, shall report to the court with
35 respect to all acts and proceedings in connection with the receivership.

1 ARTICLE 9--ADMINISTRATIVE PROCEDURES

2
3 23-55-901. Administrative proceedings.

4 All administrative proceedings under this chapter must be conducted in
5 accordance with the Arkansas Administrative Procedure Act, § 25-15-201 et
6 seq.

7
8 23-55-902. Hearings.

9 Except as otherwise provided in §§ 23-55-206(c), 23-55-404(c), 23-55-
10 803, and 23-55-807, the commissioner may not suspend or revoke a license,
11 issue an order to cease and desist, suspend or revoke the designation of an
12 authorized delegate, or assess a civil penalty without notice and an
13 opportunity to be heard. The commissioner shall also hold a hearing when
14 requested to do so by an applicant whose application for a license is denied.

16 ARTICLE 10--MISCELLANEOUS PROVISIONS

17
18 23-55-1001. Uniformity of application and construction.

19 In applying and construing this Uniform Act, consideration must be
20 given to the need to promote uniformity of the law with respect to its
21 subject matter among States that enact it.

22
23 23-55-1002. Severability clause.

24 If any provision of this chapter or its application to any person or
25 circumstance is held invalid, the invalidity does not affect other provisions
26 or applications of this chapter which can be given effect without the invalid
27 provision or application, and to this end the provisions of this chapter are
28 severable.

29
30 23-55-1003. Effective date.

31 This chapter takes effect January 1, 2008.

32
33 23-55-1004. [Reserved.]

34
35 23-55-1005. Savings and transitional provisions.

36 (a) A license issued under the Sale of Checks Act, § 23-41-101 et

1 seq., that is in effect immediately before January 1, 2008 remains in force
 2 as a license under the Sale of Checks Act, § 23-41-101 et seq., until the
 3 license's expiration date. Thereafter, the licensee is deemed to have applied
 4 for and had received a license under this chapter and must comply with the
 5 renewal requirements set forth in this chapter.

6 (b) This chapter applies to the provision of money services on or
 7 after January 1, 2008. This chapter does not apply to money transmission
 8 provided by a licensee who was licensed to provide money transmission under
