17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code § 16-17-919(a), pertaining to Washington
20 County district courts, is amended to read as follows:

21 (a)(1) Washington County shall have the following district courts and
