19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code §§ 2-1-203 and 2-1-204 are amended to read as
22 follows:

23 2-1-203. Board membership.

24 The membership of the Arkansas Young and Beginning Farmer Advisory
25 Board shall be as follows:

26 (1) Four (4) members appointed by the Governor;

27 (2) ~~Two (2) members~~ One (1) member appointed by the Lieutenant
28 Governor;

29 (3) One (1) member appointed by each United States Senator for
30 Arkansas who shall represent the state at large;

31 (4) One (1) member appointed by each Arkansas Representative of
32 the United States House of Representatives in whose congressional district
33 the member shall reside;

34 (5) ~~Two (2) members~~ appointed by the President Pro Tempore of
35 the Senate;



1 (6) Two (2) members appointed by the Speaker of the House of
2 Representatives;

3 (7) Three (3) members appointed by the Vice President for
4 Agriculture of the University of Arkansas System to represent each
5 Cooperative Extension Service district;

6 (8) One (1) member appointed by the Director of the Arkansas
7 Livestock and Poultry Commission;

8 (9) One (1) member appointed by the Director of the ~~Arkansas~~
9 ~~Soil and Water Conservation Commission~~ Arkansas Natural Resources Commission;

10 (10) One (1) member appointed by the Director of the State *Plant*
11 *Board*; and

12 ~~(11) One (1) member appointed by the State Forester; and~~

13 ~~(12) One (1) member appointed by the Director of the Department~~
14 ~~of Economic Development~~

15 (11) Two (2) members appointed by the Secretary of the Arkansas
16 Agriculture Department.

18 2-1-204. Powers and duties.

19 The Arkansas Young and Beginning Farmer Advisory Board shall:

20 (1) Communicate to the general public and the federal government
21 the importance of young and beginning farmers to agriculture in the State of
22 Arkansas;

23 (2) Address issues relating to the needs of young and beginning
24 farmers in Arkansas;

25 (3) Establish committees to develop projects relating to aspects
26 of life for young and beginning farmers in Arkansas;

27 (4)(A) Hold meetings of the board at least ~~four (4)~~ two (2)
28 times a year ~~during each calendar quarter of the year and report by December~~
29 ~~31 of each year to the Governor, the Speaker of the House of Representatives,~~
30 ~~and the President Pro Tempore of the Senate.~~

31 (B) Special meetings may be held at the call of the chair;
32 and

33 (5) Promulgate a mission statement and the administrative
34 procedures necessary to implement this subchapter; and

35 (6) Apply for, receive, and use gifts, grants, and donations
36 from private or public sources.
