19	SECTION 1. This act shall be known and may be cited as the "Emergency

22	SECTION 2. <u>Legislative intent.</u>
23	The General Assembly finds that:
24	(1) Early care and education facilities at which children from
25	birth to four (4) years of age and school-age children may spend part or all
26	of their days may not be known to emergency preparedness agencies and thus
27	may be overlooked in first response activities and in recovery planning
28	following major disasters;
29	(2) The health and social-emotional, cognitive, and physical
30	<u>development of young children may be compromised by severe traumatic</u>
31	<u>experiences;</u>
32	(3) Teachers and caregivers of young children will improve the
33	children's health and well being by being prepared for orderly evacuations

1	(4) Child care facilities are crucial to the economic
2	redevelopment of communities following major disasters; and
3	(5) State child care and emergency management agencies should
4	take steps to share data and coordinate planning, response, and recovery of

7	SECTION 3. Division of Child Care and Early Childhood Education
8	policies.
9	The Director of the Division of Child Care and Early Childhood
10	Education of the Department of Health and Human Services shall coordinate
11	efforts with other state agencies and appropriate organizations to:
12	(1)(A) Share with the Arkansas Department of Emergency
13	Management on a quarterly basis an integrated list of all licensed child care
14	facilities and all known license-exempt child care facilities, including
15	without limitation physical addresses, maximum capacity, emergency contact
16	information, hours of operation, and status as tuition subsidy, meal subsidy,
17	state-funded pre-kindergarten, and quality-rated facilities.
18	(B) The integrated list is to be sorted by county;
19	(2) Identify designated emergency shelters, including without
20	limitation local shelters and mass evacuation shelters, in proximity to all
21	licensed child care facilities and all known license-exempt facilities,
22	identify three (3) designated shelters in closest proximity to each child
23	care facility, and notify each child care facility annually of the locations
24	of those shelters;
25	(3) Coordinate efforts to notify the state emergency management
26	agency of the estimated number of children in child care facilities who could
27	be evacuated to each shelter;
28	(4) Require all licensed child care facilities to notify parents
29	annually of the shelters designated by the division as being in closest
30	proximity to those facilities;
31	(5) Include early childhood emergency preparedness courses and
32	workshops that address specific risk factors and evacuation procedures in
33	particular geographic areas among approved courses and workshops for meeting
34	requirements for in-service training for licensed child care providers in
35	those geographic areas; and

2	each level of any quality ratings above minimum licensing standards.

4	SECTION 4. Arkansas Department of Emergency Management policies.
5	The Director of the Arkansas Department of Emergency Management shall
6	coordinate efforts with other state agencies and appropriate organizations
7	<u>to:</u>
8	(1) Disseminate county-level lists of all licensed child care
9	facilities and all known license-exempt facilities, including without
10	limitation physical address, maximum capacity, hours of operation, and
11	emergency contact information, to county governments for use in search and
12	rescue during emergencies and disasters;
13	(2) Share a periodically updated statewide list of designated
14	emergency shelters, both local shelters and mass evacuation shelters, with
15	the state child care licensing agency, state child care subsidy program, and
16	state child and adult nutrition program when such a list is available; and
17	(3) Include child care facilities where critical facilities such
18	as schools, hospitals, and nursing homes are mentioned in the state response
19	plan, emergency preparedness exercises, or other guiding documents and
20	<u>activities.</u>
