9 **For An Act To Be Entitled**

10 AN ACT TO GRANT SUBPOENA POWER TO THE STATE BOARD
11 OF EDUCATION AND THE PROFESSIONAL LICENSURE
12 STANDARDS BOARD; AND FOR OTHER PURPOSES.

14 **Subtitle**

15 TO GRANT SUBPOENA POWER TO THE STATE
16 BOARD OF EDUCATION AND THE PROFESSIONAL
17 LICENSURE STANDARDS BOARD.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 *SECTION 1. Arkansas Code Title 6, Chapter 17, Subchapter 4 is amended*
23 *to add an additional section to read as follows:*

24 *6-17-424. Subpoena Powers.*

25 *(a)(1) The following boards shall have the power to issue subpoenas*
26 *and bring before the board as a witness any person in this state:*

27 *(A) Professional Licensure Standards Board, § 6-17-422;*

28 *and*

29 *(B) State Board of Education, § 6-11-101 et seq.*

30 *(2) The Professional Licensure Standards Board or the State*
31 *Board of Education shall by rule provide for the issuance of a subpoena upon*
32 *the request of a party to a proceeding pending before the Professional*
33 *Licensure Standards Board or the State Board of Education or at the request*
34 *of the Professional Licensure Standards Board or the State Board of*
35 *Education.*



1 (3) The subpoena shall:

2 (A) Be in the name of either the Professional Licensure
3 Standards Board or the State Board of Education;

4 (B) State the name of the board hearing the proceeding and
5 the name of the proceeding; and

6 (C)(i) Command each person to whom it is directed to give
7 testimony at the time and place specified in the subpoena in one (1) of the
8 following ways:

9 (a) In person;

10 (b) Before a certified court reporter under
11 oath at the place of the witness' residence or employment;

12 (c) By video-taped deposition at the place of
13 the witness' residence or employment; or

14 (d) By live video communications from the
15 witness' residence, place of employment, or a nearby facility capable of
16 providing video transmission to the board hearing the proceeding that has
17 subpoenaed the witness.

18 (ii) The manner of providing testimony under the
19 subpoena shall be conducted by video conference testimony unless another
20 manner is agreed upon by the board or commission and the person who is the
21 subject of the subpoena.

22 (4) The subpoena may require the witness to bring with him or
23 her any book, writing, or other thing under his or her control that he or she
24 is bound by law to produce in evidence.

25 (5) Service of the subpoena shall be in the manner as provided
26 by law or rule for the service of subpoenas in civil cases.

27 (b)(1) A witness who has been served by subpoena under this section
28 and who appears in person to testify at the trial or case pending before the
29 Professional Licensure Standards Board or the State Board of Education shall
30 be reimbursed for travel and attendance as provided by law.

31 (2) If a witness is served with subpoena under this section and
32 fails to provide testimony in obedience to the subpoena, the Professional
33 Licensure Standards Board or the State Board of Education may apply to the
34 circuit court of the county in which the Professional Licensure Standards
35 Board or the State Board of Education is holding the proceeding for an order
36 causing the arrest of the witness and directing that the witness be brought

1 before the court.

2 (3) The court shall have the power to punish the disobedient
3 witness for contempt as provided by the Arkansas Rules of Civil Procedure.

4 (4) A witness who has been served with a subpoena under this
5 section may challenge the validity of the subpoena in the circuit court of
6 the county in which the witness resides or is employed.

7
8 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
9 General Assembly of the State of Arkansas that the law does not provide
10 subpoena power for the State Board of Education or the Professional Licensure
11 Standards Board; that the State Board of Education and the Professional
12 Licensure Standards Board are unable to fully implement their duties due to
13 lack of subpoena. Therefore, an emergency is declared to exist and this act
14 being immediately necessary for the preservation of the public peace, health,
15 and safety shall become effective on:

16 (1) The date of its approval by the Governor;

17 (2) If the bill is neither approved nor vetoed by the Governor,
18 the expiration of the period of time during which the Governor may veto the
19 bill; or

20 (3) If the bill is vetoed by the Governor and the veto is
21 overridden, the date the last house overrides the veto.
