25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27 SECTION 1. Arkansas Code § 4-90-403(11), regarding the definitions in
28 the Arkansas New Motor Vehicle Quality Assurance Act, is amended to read as
29 follows:

30 (11)(A) “Motor vehicle” or “vehicle” means any self-propelled
31 vehicle licensed, purchased, or leased in this state ~~and~~ primarily designed
32 for the transportation of persons or property over the public streets and
33 highways~~;~~.

34 (B) ~~but~~ “Motor vehicle or “vehicle” does not include:

35 (i) mopeds, ~~mopeds,~~ Mopeds;

(b) For purposes of this definition
subchapter, the limit of ten thousand pounds (10,000 lbs.) thirteen thousand
pounds (13,000 lbs.) gross vehicle weight rating does not apply to motor
homes; or

(v) A vehicle over ten thousand pounds (10,000 lbs.)
gross vehicle weight rating that has been substantially altered after its
initial sale from a dealer to the person;
