19	(2)(A) "State agency" means any agency, department, authority,
20	board, commission, bureau, council, or other agency of the state excluding
21	institutions of higher education.
22	(B) "State agency" includes without limitation:
23	(i) The offices of the Governor, Lieutenant
24	Governor, Attorney General, Secretary of State, Treasurer of State, Auditor
