22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Arkansas Code § 2-36-302(a)(1), regarding the Northeast  
25 Arkansas District Fair Advisory Board, is amended to read as follows:

26 2-36-302. Northeast Arkansas District Fair Advisory Board.

27 (a)(1) There is created the Northeast Arkansas District Fair Advisory  
28 Board, to be composed of ~~thirty-one (31)~~ twenty-nine (29) members:

- 29 (A) Five (5) members from Mississippi County;  
30 (B) Four (4) members from Craighead County;  
31 (C) Two (2) members from Greene County;  
32 (D) One (1) member from Clay County;  
33 (E) Three (3) members from Crittenden County;  
34 (F) Two (2) members from St. Francis County;  
35 (G) One (1) member from Cross County;  
36 (H) Two (2) members from Poinsett County;



- 1 (I) Two (2) members from Jackson County;  
 2 ~~(J) Two (2) members from Independence County;~~  
 3 ~~(K)(J) One (1) member from Lawrence County;~~  
 4 ~~(L)(K) One (1) member from Randolph County;~~  
 5 ~~(M)(L) One (1) member from Lee County;~~  
 6 ~~(N)(M) One (1) member from Woodruff County; and~~  
 7 ~~(O)(N) Three (3) members from White County.~~

9 SECTION 2. Arkansas Code § 2-36-306(b), regarding the North Central  
 10 Arkansas District Fair and Livestock Show, is amended to read as follows:

11 (b) Counties composing the North Central Arkansas District Fair and  
 12 Livestock Show district shall be Cleburne County, Fulton County, Independence  
 13 County, Izard County, Sharp County, Stone County, and Van Buren County.

15 SECTION 3. Arkansas Code § 2-36-306(d), regarding the North Central  
 16 Arkansas District Fair and Livestock Show, is amended to read as follows:

17 (d)(1) There is created the North Central Arkansas District Fair  
 18 Board, to be composed of ~~twelve (12)~~ fourteen (14) members. Two (2) members  
 19 shall be selected from each county. One (1) member in each county shall be  
 20 selected by the livestock show association in the county, and one (1) shall  
 21 be selected by the Arkansas Farm Bureau Federation.

22 (2) The members of the board shall serve four-year terms. Any  
 23 vacancies arising in the board membership shall be filled in the same manner  
 24 as were the original appointments. ~~The terms of the initial members of the~~  
 25 ~~board shall be determined by lot so that the terms of three (3) members~~  
 26 ~~expire each year.~~

28 SECTION 4. NOT TO BE CODIFIED. (a) Within thirty (30) days after the  
 29 effective date of this act, the two (2) new members of the North Central  
 30 Arkansas District Fair Board from Independence County shall be selected as  
 31 provided under Arkansas Code § 2-36-306(d)(1).

32 (b) The terms of the two (2) new members of the board from  
 33 Independence County shall be:

34 (1) Staggered in sequence with the expiration dates of the board  
 35 members that held the position on the effective date of this act to avoid the  
 36 terms of the two (2) new members expiring in the same year; and
