19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 14-42-206(b)(1), concerning nominating
22 petitions, is amended to read as follows:

23 (b)(1) ~~Any~~ A person desiring to become an independent candidate for
24 municipal office in cities and towns with the mayor-council form of
25 government shall not file ~~not~~ more than ninety (90) nor less than seventy
26 (70) days ~~prior to~~ before the general election by 12:00 noon with the county
27 clerk the petition of nomination in substantially the following forms:

28 (A) For all candidates except aldermen in cities of the
29 first class and cities of the second class:

14 (B) For candidates for alderman elected by ward in cities
15 of the first class and cities of the second class, the nominating petitions
16 shall be signed only by qualified electors of the ward in the following
17 manner:
