10 ARKANSAS CODE OF 1987 CONCERNING PUBLIC FINANCE; AND  
11 FOR OTHER PURPOSES.

## Subtitle

15 TO MAKE VARIOUS CORRECTIONS TO TITLE 19  
16 OF THE ARKANSAS CODE OF 1987 CONCERNING  
17 PUBLIC FINANCE.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 19-1-701(b) is amended to read as follows  
23 to insert an agency reference that was inadvertently removed:

24 (b) A fiscal impact statement shall be developed with the guidance of  
25 the Office of Economic and Tax Policy of the Bureau of Legislative Research  
26 and with the approval of the Department of Education.  
27

28 SECTION 2. Arkansas Code § 19-5-302(5) is amended to read as follows  
29 to correct the name of a fund account:

30 (5)(A) ~~Department of~~ Arkansas Economic Development Commission  
31 Fund Account. The ~~Department of~~ Arkansas Economic Development Commission  
32 Fund Account shall be used for the maintenance, operation, and improvement  
33 required by the Arkansas Economic Development Commission and the Arkansas  
34 Economic Development Council in carrying out the powers, functions, and  
35 duties as set out in §§ 15-4-101, 15-4-102, 15-4-201 – 15-4-204, 15-4-206,  
36 15-4-209 – 15-4-212, 15-4-501 – 15-4-524, and 15-10-201 – 15-10-206, or other



1 duties imposed by law upon the Arkansas Economic Development Commission or  
2 the Arkansas Energy Office.

3 (B) The ~~Department of Arkansas~~ Economic Development  
4 Commission Fund Account shall consist of:

5 (i) Those general revenues as may be provided by  
6 law;

7 (ii) Nonrevenue income derived from services  
8 performed by the various divisions of the Arkansas Economic Development  
9 Council; and

10 (iii) Any other funds that may be provided by law;  
11

12 SECTION 3. Arkansas Code § 19-5-304(2) is amended to read as follows  
13 to correct the name of the fund account and the names of other entities as  
14 those names were changed by Acts 2009, No. 787 and to make stylistic changes:

15 (2)(A) Department of ~~Workforce~~ Career Education Fund Account.

16 The Department of ~~Workforce~~ Career Education Fund Account shall be used to  
17 provide support for those programs placed under the direction of the Director  
18 of the Department of ~~Workforce~~ Career Education as authorized by §§ 6-11-101,  
19 6-11-102, 25-6-101, 25-6-102, and Acts 1981, No. 64, § 4, and any other laws  
20 imposing functions, powers, and duties upon the State Board of ~~Workforce~~  
21 Career Education and ~~Career Opportunities~~, including, ~~but not necessarily~~  
22 ~~limited to,~~ without limitation the following:

23 (i) Vocational, technical, and adult education;

24 (ii) Adult basic education;

25 (iii) Manpower training;

26 (iv) Vocational standards;

27 (v) Industry training programs; and

28 (vi) Those functions, programs, and responsibilities

29 transferred to the Department of ~~Workforce~~ Career Education as authorized by  
30 these statutes.

31 (B) The Department of ~~Workforce~~ Career Education Fund  
32 Account shall consist of those general revenues as may be provided by the  
33 Revenue Stabilization Law, § 19-5-101 et seq.;

34  
35 SECTION 4. Arkansas Code § 19-5-307(a) is amended to read as follows  
36 to delete obsolete references:

1 (a) The Public Health Fund shall be used for the maintenance,  
2 operation, and improvement required by the regional health centers and the  
3 various divisions of the Department of Health in carrying out the powers,  
4 functions, and duties as set out in § 20-7-102 et seq., ~~and all laws~~  
5 ~~amendatory thereto, and § 20-11-201 et seq. [repealed],~~ or other duties  
6 imposed by law upon:

7 (1) The Department of Health;

8 (2) The Director of the Department of Health;

9 (3) The State Board of Health;

10 (4) The Secretary of the State Board of Health, or the State  
11 Health Officer, whose office was transferred under ~~the provisions of~~ § 25-9-  
12 101 to the Department of Health; and

13 (5) The State Cancer Commission, which was transferred to the  
14 Department of Health by § 25-9-101; ~~and~~

15 ~~(6) The Arkansas Tuberculosis Sanatorium, which was transferred~~  
16 ~~to the Department of Health by § 25-9-101.~~

17  
18 SECTION 5. DO NOT CODIFY. The enactment and adoption of this act  
19 shall not repeal, expressly or impliedly, the acts passed at the regular  
20 session of the Eighty-Eighth General Assembly. All such acts shall have the  
21 full force and effect and, so far as those acts intentionally vary from or  
22 conflict with any provision contained in this act, those acts shall have the  
23 effect of subsequent acts and as amending or repealing the appropriate parts  
24 of the Arkansas Code of 1987.
