22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. REGULAR SALARIES - HISTORY COMMISSION. There is hereby
25 established for the Department of Parks and Tourism - Arkansas History
26 Commission for the 2012-2013 fiscal year, the following maximum number of
27 regular employees.

10 SECTION 2. EXTRA HELP - HISTORY COMMISSION. There is hereby
 11 authorized, for the Department of Parks and Tourism - Arkansas History
 12 Commission for the 2012-2013 fiscal year, the following maximum number of
 13 part-time or temporary employees, to be known as "Extra Help", payable from
 14 funds appropriated herein for such purposes: three (3) temporary or part-
 15 time employees, when needed, at rates of pay not to exceed those provided in
 16 the Uniform Classification and Compensation Act, or its successor, or this
 17 act for the appropriate classification.

19 SECTION 3. APPROPRIATION - HISTORY COMMISSION - STATE. There is hereby
 20 appropriated, to the Department of Parks and Tourism - Arkansas History
 21 Commission, to be payable from the Parks and Tourism Fund Account, for
 22 personal services and operating expenses of the Department of Parks and
 23 Tourism - Arkansas History Commission for the fiscal year ending June 30,
 24 2013, the following:

4 SECTION 4. APPROPRIATION - HISTORY COMMISSION - CASH. There is hereby

5 appropriated, to the Department of Parks and Tourism - Arkansas History

6 Commission, to be payable from the cash fund deposited in the State Treasury

7 as determined by the Chief Fiscal Officer of the State, for operating

8 expenses of the Department of Parks and Tourism - Arkansas History Commission

9 for the fiscal year ending June 30, 2013, the following:

21 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

22 authorized by this act shall be limited to the appropriation for such agency

23 and funds made available by law for the support of such appropriations; and

24 the restrictions of the State Procurement Law, the General Accounting and

25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

26 Procedures and Restrictions Act, or their successors, and other fiscal

27 control laws of this State, where applicable, and regulations promulgated by

28 the Department of Finance and Administration, as authorized by law, shall be

29 strictly complied with in disbursement of said funds.

30

31 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General

32 Assembly that any funds disbursed under the authority of the appropriations

33 contained in this act shall be in compliance with the stated reasons for

34 which this act was adopted, as evidenced by the Agency Requests, Executive

35 Recommendations and Legislative Recommendations contained in the budget

36 manuals prepared by the Department of Finance and Administration, letters, or

1 summarized oral testimony in the official minutes of the Arkansas Legislative
2 Council or Joint Budget Committee which relate to its passage and adoption.

3
4 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General
5 Assembly, that the Constitution of the State of Arkansas prohibits the
6 appropriation of funds for more than a one (1) year period; that the
7 effectiveness of this Act on July 1, 2012 is essential to the operation of
8 the agency for which the appropriations in this Act are provided, and that in
9 the event of an extension of the legislative session, the delay in the
10 effective date of this Act beyond July 1, 2012 could work irreparable harm
11 upon the proper administration and provision of essential governmental
12 programs. Therefore, an emergency is hereby declared to exist and this Act
13 being necessary for the immediate preservation of the public peace, health
14 and safety shall be in full force and effect from and after July 1, 2012.
