20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

17 PROMOTIONAL ITEMS. The Department of Arkansas State Police is hereby
 18 authorized to purchase from Maintenance & General Operations Classifications
 19 in the Operations Appropriation provided by this Act, up to an amount not to
 20 exceed \$2,500 each fiscal year, promotional items, authorized by the Director
 21 of the Department to meet requirements of the Arkansas State Police Strategic
 22 Recruitment Plan.

 26 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COURT

28 AWARDS FUND TRANSFER PROVISION. Monies deposited in the Court Awards Fund
 29 each fiscal year may be used for motor vehicle purchases and associated taxes
 30 and/or motor vehicle equipping and renovation costs, agency operational needs
 31 and capital improvements for the Department of Arkansas State Police.

32 Provided however, funds received from the Special State Assets Forfeiture
 33 Fund shall be deposited into the Court Awards Fund to be used by the
 34 Department of Arkansas State Police for law enforcement purposes consistent
 35 with governing federal law. The Department of Arkansas State Police may also
 36 request a fund transfer from the Court Awards Fund or the Department of

1 Arkansas State Police Fund to the Motor Vehicle Acquisition Revolving Fund.
2 The provisions of this section shall be subject to prior review and approval
3 of the Arkansas Legislative Council or Joint Budget Committee.

4 Determining the maximum number of employees and the maximum amount of
5 appropriation and general revenue funding for a state agency each fiscal year
6 is the prerogative of the General Assembly. This is usually accomplished by
7 delineating such maximums in the appropriation act(s) for a state agency and
8 the general revenue allocations authorized for each fund and fund account by
9 amendment to the Revenue Stabilization law. Further, the General Assembly

25 PROVISION. The Department of Arkansas State Police is hereby authorized,
26 after seeking the approval of the Chief Fiscal Officer of the State, to
27 request transfer from the appropriation made herein for "Confiscated Funds
28 Transfer" to the Maintenance and General Operations classifications
29 established in the operations appropriation of the Department of Arkansas
30 State Police, and may be used for motor vehicle purchases and associated
31 taxes and/or motor vehicle equipping/renovation costs, agency operational
32 needs and capital improvements for the Department of Arkansas State Police.
33 Fund transfers may be requested from the Court Awards Fund to the Department
34 of Arkansas State Police Fund in the same amount and for the same purposes as
35 the appropriation transfer requested under the provisions of this section.
36 The provisions of this section shall be subject to prior review and approval

1 of the Arkansas Legislative Council or Joint Budget Committee.

2 Determining the maximum number of employees and the maximum amount of
3 appropriation and general revenue funding for a state agency each fiscal year
4 is the prerogative of the General Assembly. This is usually accomplished by
5 delineating such maximums in the appropriation act(s) for a state agency and
6 the general revenue allocations authorized for each fund and fund account by
7 amendment to the Revenue Stabilization law. Further, the General Assembly
8 has determined that the Department of Arkansas State Police may operate more

23 VEHICLE ACQUISITION REVOLVING FUND – MOTOR VEHICLE PURCHASES/RENOVATION. At
24 least fifty percent (50%) of the general revenues and/or general improvement
25 funds deposited into the Motor Vehicle Acquisition Revolving Fund shall be
26 used for motor vehicle purchases and/or motor vehicle renovation costs for
27 the Department of Arkansas State Police.

28 The provisions of this section shall be in effect only from July 1, ~~2012~~
29 2013 through June 30, ~~2013~~ 2014.

30
31 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OVERTIME.
33 The Department of Arkansas State Police is hereby authorized to make overtime
34 payments from such funds and appropriations provided for overtime payments to
35 those officers or other employees that are currently assigned or may be
36 assigned by the Director of the Department of Arkansas State Police to

1 Special Law Enforcement Task Forces and other special programs reimbursable
2 to Arkansas State Police by federal or local authorities as approved by the
3 Director of the Department of Arkansas State Police. All such overtime
4 payments shall be processed through the State Accounting System and shall be
5 in addition to the Regular Salaries and benefits accruing to the employee.

6 The provisions of this section shall be in effect only from July 1, ~~2012~~
7 2013 through June 30, ~~2013~~ 2014.

8
9 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR
11 VEHICLE PURCHASE. The Department of Arkansas State Police is hereby
12 authorized to purchase motor vehicles from the appropriations authorized for
13 Capital Outlay in the State Police Operations appropriation in this Act.
14 Motor vehicles donated to Arkansas State Police and confiscated vehicles used
15 for Arkansas State Police operations shall not be included in the maximum
16 number of authorized passenger vehicles.

17 The provisions of this section shall be in effect only from July 1, ~~2012~~
18 2013 through June 30, ~~2013~~ 2014.

19
20 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. UNIFORM
22 EMPLOYEE HEALTH INSURANCE PROGRAM REPORTING. The Department of Arkansas
23 State Police shall report monthly to the Governor, the Chief Fiscal Officer
24 of the State and to the Arkansas Legislative Council or Joint Budget
25 Committee regarding the activity and condition for the uniformed employee
26 health insurance plan. The report shall include, but not limited to, the
27 beginning reserve fund balance, contributions made during the month, claims
28 paid, and the ending fund balance of the month. In the event it is determined
29 that the cost to adequately maintain the uniform employee health insurance
30 plan is not feasible within the existing resources available to the
31 department, the ~~88th~~ 89th General Assembly shall study the feasibility and
32 desirability of discontinuing the self-insurance program and instead provide
33 medical and hospital insurance to uniform employees through the public
34 employees insurance program.

35 The provisions of this section shall be in effect only from July 1, ~~2012~~
36 2013 through June 30, ~~2013~~ 2014.

1
2 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
4 EXTRAORDINARY EXPENSES. The Department of Arkansas State Police is hereby
5 authorized to purchase from Maintenance & Operations Classifications in the
6 Operations Appropriation provided by in this Act, up to an amount not to
7 exceed two thousand five hundred dollars (\$2,500) each fiscal year, for
8 emergency purchases for food, drinks and other essential items during
9 emergency operations only when authorized by the Agency Director. During an
10 emergency, an ASP employee may be designated and authorized, by the Director,
11 to incur expenses for all deployed personnel.

12 The provisions of this section shall be in effect only from July 1, ~~2012~~
13 2013 through June 30, ~~2013~~ 2014.

14
15 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FLAGS.
17 The Department of Arkansas State Police is hereby authorized to award one (1)
18 United States flag to the family of any Arkansas State Police Commissioned
19 Officer killed in the line of duty. This provision will be effective for
20 Arkansas State Police Commissioned Officers killed in the line of duty after
21 July 1, 2011.

22 The provisions of this section shall be in effect only from July 1,
23 ~~2012~~ 2013 to June 30, ~~2013~~ 2014.

24
25 *SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE*
26 *ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.*
27 *This act includes sufficient appropriation and funding to address salary*
28 *inequities with the ranks of State Police Corporals and State Police*
29 *Sergeants. On July 1, 2013 equity salary adjustments up to the career level*
30 *of the assigned grade may be awarded to current employees in accordance with*
31 *the plan established by the Office of Personnel Management and approved by*
32 *the Chief Fiscal Officer.*

33
34 SECTION 23. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
35 authorized by this act shall be limited to the appropriation for such agency
36 and funds made available by law for the support of such appropriations; and

1 the restrictions of the State Procurement Law, the General Accounting and
2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
3 Procedures and Restrictions Act, or their successors, and other fiscal
4 control laws of this State, where applicable, and regulations promulgated by
5 the Department of Finance and Administration, as authorized by law, shall be
6 strictly complied with in disbursement of said funds.

7
8 SECTION 24. LEGISLATIVE INTENT. It is the intent of the General
9 Assembly that any funds disbursed under the authority of the appropriations
10 contained in this act shall be in compliance with the stated reasons for
11 which this act was adopted, as evidenced by the Agency Requests, Executive
12 Recommendations and Legislative Recommendations contained in the budget
13 manuals prepared by the Department of Finance and Administration, letters, or
14 summarized oral testimony in the official minutes of the Arkansas Legislative
15 Council or Joint Budget Committee which relate to its passage and adoption.

16
17 SECTION 25. EMERGENCY CLAUSE. It is found and determined by the
18 General Assembly, that the Constitution of the State of Arkansas prohibits
19 the appropriation of funds for more than a one (1) year period; that the
20 effectiveness of this Act on July 1, 2013 is essential to the operation of
21 the agency for which the appropriations in this Act are provided, and that in
22 the event of an extension of the legislative session, the delay in the
23 effective date of this Act beyond July 1, 2013 could work irreparable harm
24 upon the proper administration and provision of essential governmental
25 programs. Therefore, an emergency is hereby declared to exist and this Act
26 being necessary for the immediate preservation of the public peace, health
27 and safety shall be in full force and effect from and after July 1, 2013.
