EMERGENCY CLAUSE. It is found and determined by the General 34 Assembly, that the Constitution of the State of Arkansas prohibits the 35 appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2013 is essential to the operation of 36
