SECTION 5. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS GOVERNOR'S SCHOLARS ADDITIONAL FUNDING. The additional two million dollars (\$2,000,000) of general revenue funding authorized in this act for the Higher Education Grants Fund Account that is above the 2012-2013 fiscal year Revenue Stabilization Law allocation for the account shall be used exclusively as additional funding for the Arkansas Governor's Scholars Program during the 2013-2014 fiscal year. SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General Assembly of the State of Arkansas that changes in the state's fiscal laws must take effect at the beginning of the fiscal year, and that if the current legislative session is extended such that the 90-day period is later than July 1, 2013 the changes will not be timely. Therefore, an emergency is declared to exist and this act being immediately necessary for the preservation of the public peace, health, and safety shall become effective on July 1, 2013. /s/Joint Budget Committee APPROVED: 04/23/2013
