11 AN ACT TO AMEND PROVISIONS OF THE ARKANSAS ACADEMIC
12 CHALLENGE SCHOLARSHIP PROGRAM, PART 2, CONCERNING
13 SCHOLARSHIP AWARDS FROM NET PROCEEDS OF THE LOTTERY;
14 TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES.

19 TO AMEND PROVISIONS OF THE ARKANSAS
20 ACADEMIC CHALLENGE SCHOLARSHIP PROGRAM,
21 PART 2, CONCERNING SCHOLARSHIP AWARDS
22 FROM NET PROCEEDS OF THE LOTTERY; AND TO
23 DECLARE AN EMERGENCY.

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
27

28 *SECTION 1. Arkansas Code § 6-85-212(e)(1)(A), concerning scholarship*
29 *award amounts for the Arkansas Academic Challenge Scholarship Program, Part*
30 *2, is amended to read as follows:*

31 *(e)(1)(A) Beginning with the ~~2011-2012~~ 2013-2014 academic year, the*
32 *scholarship award amount under this subchapter for an academic year for a*
33 *full-time recipient enrolled in a four-year approved institution of higher*
34 *education is ~~four thousand five hundred dollars (\$4,500):~~*

35 *(i) Two thousand dollars (\$2,000) for a recipient in his*
36 *or her freshman year;*



1 (ii) Three thousand dollars (\$3,000) for a recipient in
2 his or her sophomore year;

3 (iii) Four thousand dollars (\$4,000) for a recipient in
4 his or her junior year; and

5 (iv) Five thousand dollars (\$5,000) for a recipient in his
6 or her senior year.

7
8 *SECTION 2. Arkansas Code § 6-85-212(e)(2)(A), concerning scholarship*
9 *award amounts for nontraditional students in the Arkansas Academic Challenge*
10 *Scholarship Program, Part 2, is amended to read as follows:*

11 (2)(A)(i) The department shall award an aggregate amount of
12 scholarship awards to nontraditional students beginning with the 2010-2011
13 academic year of twelve million dollars (\$12,000,000).

14 (ii) Beginning with the 2014-2015 academic year, the
15 department shall award an aggregate amount of scholarship awards to
16 nontraditional students of sixteen million (\$16,000,000).

18 *SECTION 3. Arkansas Code § 6-85-212(e)(3), concerning scholarship*
19 *award amounts under the Arkansas Academic Challenge Scholarship Program, Part*
20 *2, to students attending two-year institutions of higher education, is*
21 *amended to read as follows:*

22 (3) The scholarship award ~~for an academic year~~ for a full-time
23 student enrolled in one (1) of the following institutions of higher education
24 is ~~one half (1/2) of the scholarship award amount for a full-time undergraduate~~
25 ~~student enrolled in a four-year approved institution of higher education~~ two
26 thousand dollars (\$2,000):

27 (A) A two-year approved institution of higher education;

28 (B) A branch campus of a four-year approved institution of
29 higher education; or

30 (C) An approved nursing school.

31
32 *SECTION 4. EMERGENCY CLAUSE. It is found and determined by the*
33 *General Assembly of the State of Arkansas that increasing the number of*
34 *Arkansans obtaining postsecondary credentials is critical to the economic*
35 *health of the state and its citizens; that the Arkansas Scholarship Lottery*
36 *provides the opportunity for tens of thousands of Arkansans to obtain*

1 postsecondary education; that the deadline for scholarship applications is
2 June 1; that the financial integrity of the Arkansas Scholarship Lottery is
3 critical to the continued existence of the scholarships; and that this act is
4 immediately necessary because the Department of Higher Education must
5 promulgate rules to implement this act well before June 1, 2013, in order to
6 provide eligible Arkansans the opportunity to apply for the scholarship.
7 Therefore, an emergency is declared to exist and this act being immediately
8 necessary for the preservation of the public peace, health, and safety shall
9 become effective on:

10 (1) The date of its approval by the Governor;

11 (2) If the bill is neither approved nor vetoed by the Governor,
12 the expiration of the period of time during which the Governor may veto the
13 bill; or

14 (3) If the bill is vetoed by the Governor and the veto is
15 overridden, the date the last house overrides the veto.
