9 AN ACT TO AMEND THE REQUIREMENTS FOR MULTIYEAR  
10 VEHICLE REGISTRATION; AND FOR OTHER PURPOSES.

### Subtitle

14 TO AMEND THE REQUIREMENTS FOR MULTIYEAR  
15 VEHICLE REGISTRATION.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
19

20 SECTION 1. Arkansas Code § 27-14-612(c)-(e), concerning multiyear  
21 registration requirements, are amended to read as follows:

22 (c)~~(1)~~ The owner of a personal-use vehicle, who has owned the vehicle  
23 for a twelve (12) month renewal period following initial registration by the  
24 owner, may ~~submit~~ request a multiyear personal-use vehicle registration for a  
25 period of two (2) or three (3) years by providing the following information  
26 to the office with the application:

27 ~~(A)(1)~~ All information necessary for the registration and  
28 licensing of the vehicle under law to include:

29 (A) Proof of current insurance coverage on the vehicle to  
30 be registered as required under § 27-13-102;

31 (B) Proof of payment of personal property taxes; and

32 (C) Proof of listing the vehicle for assessment;

33 ~~(i) (2)~~ Proof that property taxes on the vehicle to be  
34 registered have been timely paid by the applicant for the preceding two (2)  
35 years; and

36 ~~(ii) Proof that the motor vehicle has been insured~~



1 as required under ~~§ 27-22-104~~ and the Motor Vehicle Safety Responsibility  
2 Act, ~~§ 27-19-101 et seq.~~, for the preceding two (2) years; and

3 ~~(B)(3)~~ Payment of the fees for registration and licensing for  
4 two (2) years;

5 (A) Two (2) years, if the registration is for a period of  
6 two (2) years; and

7 (B) Three (3) years, if the registration is for a period  
8 of three (3) years.

9 ~~(2) The owner of a personal use vehicle may submit a multiyear~~  
10 ~~personal use vehicle registration for a period of three (3) years by~~  
11 ~~providing the following information to the office with the application:~~

12 ~~(A) All information necessary for the registration and~~  
13 ~~licensing of the vehicle under law to include:~~

14 ~~(i) Proof that property taxes have been timely paid~~  
15 ~~for the preceding three (3) years; and~~

16 ~~(ii) Proof that the motor vehicle has been insured~~  
17 ~~as required under § 27-22-104 and the Motor Vehicle Safety Responsibility~~  
18 ~~Act, § 27-19-101 et seq., for the preceding three (3) years; and~~

19 ~~(B) Payment of the fees for registration and licensing for~~  
20 ~~three (3) years.~~

21 ~~(d) A personal use vehicle is not eligible for registration under this~~  
22 ~~section if it has not been licensed and registered for the period that the~~  
23 ~~owner seeks to register the vehicle for multiple years prior to the owner's~~  
24 ~~seeking to register the vehicle for multiple years.~~

25 ~~(e) (d)~~ The Office of Motor Vehicle may promulgate rules for the  
26 administration of this section.

28 SECTION 2. EFFECTIVE DATE. This act is effective on and after January  
29 1, 2014.
