22	<u>(a) There is established a legislative task force to be known as the</u>
23	"Legislative Task Force on the Taxation of Nonalcoholic Beverages".
24	(b) The task force shall be composed of the following members:
25	(1) Five (5) members appointed by the President Pro Tempore of
26	<u>the Senate as follows:</u>
27	(A) Two (2) members of the Senate, one of whom shall be
28	appointed to serve as cochair of the task force;
29	(B) One (1) representative of a retail chain operating in
30	<u>the state;</u>
31	(C) One (1) owner or operator of a fast food restaurant
32	located in the state; and
33	(D) One (1) owner or operator of a full-service restaurant
