23	SECTION 1. Arkansas Code § 20-81-105 is amended to read as follows:
24	20-81-105. Veterans' Home.
25	(a) The Department of Veterans' Affairs is authorized to establish and
26	maintain a Veterans' Home in the building formerly used as the Arkansas
27	School for the Blind and the Arkansas School for the Deaf at Twentieth and
28	Madison Streets in Little Rock, Arkansas at a location selected by the
29	Director of the Department of Veterans' Affairs, after seeking advice from
30	the Arkansas Veterans' Commission, and the Arkansas Veterans' Home Task
31	Force.
32	(b) The department is authorized to employ staff to operate the home
33	as it deems appropriate and as $\frac{may}{be}$ authorized by biennial appropriation.
34	(c)(1) The home shall be operated under the supervision of the
35	department.
36	(2) The Director of the Department of Veterans' Affairs <u>director</u>

- 1 shall be the administrative head of the home.
- 2 (d)(1) The department shall promulgate appropriate guidelines for
- 3 determining eligibility of veterans for admission to the home, and the
- 4 monetary charges to be made for veterans residing in the home. All guidelines
- 5 shall conform to the federal requirements which must be met to qualify the
- 6 home as a nursing home and domiciliary for veterans and to render the home
