21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14, is
24 amended to add an additional section to read as follows:

25 27-24-1412. Fraternal Order of Police.

26 (a) The Director of the Department of Finance and Administration shall
27 issue a special license plate for the Arkansas State Lodge Fraternal Order of
28 Police in the manner and subject to the conditions provided for under this
29 subchapter.

30 (b) The Arkansas State Lodge Fraternal Order of Police motor vehicle
31 special license plate shall be:

32 (1)(A) Designed by the Arkansas State Lodge Fraternal Order of
33 Police.

34 (B) The design shall be submitted for design approval by
35 the director under rules promulgated by the director; and

36 (2) Numbered consecutively.



1 (c) The procedures concerning costs for issuance under § 27-24-
2 1404(c)(1)(A) shall apply.

3 (d) The Department of Finance and Administration shall issue a special
4 license plate under this section to the owner of a motor vehicle upon payment
5 of:

6 (1) The fee required by law for registration of the motor
7 vehicle;

8 (2)(A) Twenty-five dollars (\$25.00) to cover the design-use
9 contribution.

10 (B) The design-use contribution shall be remitted monthly
11 to the Arkansas State Lodge Fraternal Order of Police; and

12 (3)(A) A handling and administrative fee of ten dollars
13 (\$10.00).

14 (B) The handling and administrative fee shall be:

15 (i) Deposited into the State Central Services Fund
16 for the benefit of the Revenue Division of the Department of Finance and
17 Administration; and

18 (ii) Credited to the division as supplemental and in
19 addition to all other funds that may be deposited for the benefit of the
20 division.

21 (C) The handling and administrative fee shall not be
22 considered or credited to the division as direct revenue.

23 (e)(1) A special license plate issued under this section may be
24 renewed annually or replaced under the procedures set out in § 27-24-1405.

25 (2) However, the division shall remit the fees collected under §
26 27-24-1405(b)(2) on a monthly basis as set forth in subsection (d)(2)(B) of
27 this section.

28
29 SECTION 2. EFFECTIVE DATE. This act is effective on and after January
30 1, 2014.
