10 AN ACT TO AMEND THE LAW CONCERNING THE SPRING BREAK
11 HOLIDAY FOR PUBLIC SCHOOLS; AND FOR OTHER PURPOSES.

Subtitle

15 TO AMEND THE LAW CONCERNING THE SPRING
16 BREAK HOLIDAY FOR PUBLIC SCHOOLS.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 6-10-106(d), concerning the common spring
22 break for public schools, is amended to read as follows:

23 (d)(1) ~~For school years 2011-2012 and 2012-2013, each~~ A public school
24 district that provides a week-long holiday for spring break shall schedule
25 the spring break holiday for five (5) consecutive school days beginning on
26 the Monday of the thirty-eighth week of the school year.

27 (2) The thirty-eighth week of the school year shall be
28 calculated by counting as week one the first week in July that begins on a
29 Sunday.

30 (3) Nothing in this subsection (d) shall prevent a public school
31 district from providing fewer than five (5) consecutive school days for the
32 spring break holiday to comply with the department's requirement for a
33 minimum number of days for student attendance under the Standards for
34 Accreditation of Arkansas Public Schools and School Districts.

35 ~~(4)(A) There is created an advisory committee to review the~~

 12 ~~Hospitality Association or his or her designee;~~

13 ~~(v) The Executive Director of the Arkansas~~
 14 ~~Activities Association or his or her designee;~~

15 ~~(vi) The Executive Director of the Arkansas~~
 16 ~~Association of Educational Administrators or his or her designee;~~

17 ~~(vii) The Executive Director of the Arkansas~~
 18 ~~Education Association or his or her designee; and~~

19 ~~(viii) The Executive Director of the Arkansas School~~
 20 ~~Boards Association or his or her designee.~~

21 ~~(C) The commissioner or his or her designee shall serve as~~
 22 ~~chair of the advisory committee.~~

23 ~~(D) The advisory committee shall meet upon the call of the~~
 24 ~~chair but at least annually at a location designated by the chair.~~

25 ~~(E) By August 1, 2012, and August 1, 2013, the advisory~~
 26 ~~committee shall report to the Senate Committee on Education and the House~~
 27 ~~Committee on Education any findings and recommendations of the advisory~~
 28 ~~committee for the impact of this section on the coordination of academic,~~
 29 ~~extracurricular, and athletic school activities and on state tourism.~~

30 ~~(F) The advisory committee's work shall end upon the~~
 31 ~~filing of the August 1, 2013, report unless the Senate Committee on Education~~
 32 ~~or the House Committee on Education requests further study by the advisory~~
 33 ~~committee.~~
