20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
23 for the Office of Attorney General, for the 2013-2014 fiscal year, the
24 following maximum number of regular employees which shall be supplemental and
25 in addition to those positions authorized in Section 1 of Act 1332 of 2013.

SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated, to the Office of Attorney General, to be payable from the State Central Services Fund, for personal services of the Office of Attorney General which shall be supplemental and in addition to those funds appropriated in Section 3 of Act 1332 of 2013, the following:

SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that funds provided by the General Assembly for the operations of the Office of Attorney General are, due to unforeseen circumstances, insufficient for the Office of Attorney General to continue to provide essential governmental services; that the provisions of this act will provide

1 the necessary monies for the Office of Attorney General to continue such
2 services; and that a delay in the effective date of this Act could work
3 irreparable harm upon the proper administration and provision of essential
4 governmental programs. Therefore, an emergency is hereby declared to exist
5 and this Act being necessary for the immediate preservation of the public
6 peace, health and safety shall be in full force and effect from and after the
7 date of its passage and approval.

8 If the bill is neither approved nor vetoed by the Governor, it shall
9 become effective on the expiration of the period of time during which the
10 Governor may veto the bill. If the bill is vetoed by the Governor and the
11 veto is overridden, it shall become effective on the date the last house
12 overrides the veto.
