8 AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
9 IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF
10 ARKANSAS STATE POLICE; AND FOR OTHER PURPOSES.

14 AN ACT FOR THE DEPARTMENT OF ARKANSAS
15 STATE POLICE REAPPROPRIATION.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - GENERAL IMPROVEMENT PROJECTS. There is
21 hereby appropriated, to the Department of Arkansas State Police, to be
22 payable from the General Improvement Fund or its successor fund or fund
23 accounts, for the Department of Arkansas State Police the following:

24 (A) Effective July 1, 2015, the balance of the appropriation provided
25 in Item (A) Section 1 of Act 43 of 2014, for personal services and operating
26 expenses associated with conducting a Troop School, in a sum not to exceed
27\$6,000,000.

28 (B) Effective July 1, 2015, the balance of the appropriation provided
29 in Item (B) Section 1 of Act 43 of 2014, for fleet vehicle purchase,
30 equipping and sales tax, in a sum not to exceed.....\$7,200,000.

31 (C) Effective July 1, 2015, the balance of the appropriation provided
32 in Item (C) Section 1 of Act 43 of 2014, for the replacement of microwave
33 radio equipment installed on the Arkansas Wireless Information Network
34 (AWIN), in a sum not to exceed.....\$12,900,000.

35 (D) Effective July 1, 2015, the balance of the appropriation provided
36 in Item (D) Section 1 of Act 43 of 2014, for building and tower remediation



1 of the Arkansas Wireless Information Network System, in a sum not to exceed
2\$1,500,000.

3 (E) Effective July 1, 2015, the balance of the appropriation provided
4 in Item (E) Section 1 of Act 43 of 2014, for information technology
5 equipment, software, license, update and enhancement, in a sum not to exceed
6\$1,640,617.

7 (F) Effective July 1, 2015, the balance of the appropriation provided
8 in Item (F) Section 1 of Act 43 of 2014, for Arkansas State Police building
9 repairs and improvements, in a sum not to exceed.....\$50,500.

10 (G) Effective July 1, 2015, the balance of the appropriation provided
11 in Item (G) Section 1 of Act 43 of 2014, for maintenance, renovation,
12 construction, equipping, improvement, upgrade, land acquisition and repairs,
13 in a sum not to exceed.....\$175,000.

15 SECTION 2. REAPPROPRIATION - SUSTAINABLE BUILDING DESIGN PROGRAM.

16 There is hereby appropriated, to the Department of Arkansas State Police, to
17 be payable from the Sustainable Building Design Revolving Loan Fund, for the
18 Department of Arkansas State Police the following:

19 (A) Effective July 1, 2015, the balance of the appropriation provided
20 in Section 13 of Act 58 of 2014, for renovation of state owned property, in a
21 sum not to exceed.....\$534,697.

23 SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
24 obligations otherwise incurred in relation to the project or projects
25 described herein in excess of the State Treasury funds actually available
26 therefor as provided by law. Provided, however, that institutions and
27 agencies listed herein shall have the authority to accept and use grants and
28 donations including Federal funds, and to use its unobligated cash income or
29 funds, or both available to it, for the purpose of supplementing the State
30 Treasury funds for financing the entire costs of the project or projects
31 enumerated herein. Provided further, that the appropriations and funds
32 otherwise provided by the General Assembly for Maintenance and General
33 Operations of the agency or institutions receiving appropriation herein shall
34 not be used for any of the purposes as appropriated in this act.

35 (B) The restrictions of any applicable provisions of the State Purchasing
36 Law, the General Accounting and Budgetary Procedures Law, the Revenue

1 Stabilization Law and any other applicable fiscal control laws of this State
 2 and regulations promulgated by the Department of Finance and Administration,
 3 as authorized by law, shall be strictly complied with in disbursement of any
 4 funds provided by this act unless specifically provided otherwise by law.

 6 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
 7 Assembly that any funds disbursed under the authority of the appropriations
 8 contained in this act shall be in compliance with the stated reasons for
 9 which this act was adopted, as evidenced by the Agency Requests, Executive
 10 Recommendations and Legislative Recommendations contained in the budget
 11 manuals prepared by the Department of Finance and Administration, letters, or
 12 summarized oral testimony in the official minutes of the Arkansas Legislative
 13 Council or Joint Budget Committee which relate to its passage and adoption.

 15 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
 16 Assembly, that the Constitution of the State of Arkansas prohibits the
 17 appropriation of funds for more than a one (1) year period; that the
 18 effectiveness of this Act on July 1, 2015 is essential to the operation of
 19 the agency for which the appropriations in this Act are provided, and that in
 20 the event of an extension of the legislative session, the delay in the
 21 effective date of this Act beyond July 1, 2015 could work irreparable harm
 22 upon the proper administration and provision of essential governmental
 23 programs. Therefore, an emergency is hereby declared to exist and this Act
 24 being necessary for the immediate preservation of the public peace, health
 25 and safety shall be in full force and effect from and after July 1, 2015.
