Provided, however, that institutions and 28 agencies listed herein shall have the authority to accept and use grants and 29 donations including Federal funds, and to use its unobligated cash income or 30 funds, or both available to it, for the purpose of supplementing the State 31 Treasury funds for financing the entire costs of the project or projects 32 enumerated herein. Provided further, that the appropriations and funds 33 otherwise provided by the General Assembly for Maintenance and General 34 Operations of the agency or institutions receiving appropriation herein shall 35 not be used for any of the purposes as appropriated in this act. 36 (B) The restrictions of any applicable provisions of the State Purchasing

Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

7 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General 8 Assembly that any funds disbursed under the authority of the appropriations 9 contained in this act shall be in compliance with the stated reasons for 10 which this act was adopted, as evidenced by the Agency Requests, Executive 11 Recommendations and Legislative Recommendations contained in the budget 12 manuals prepared by the Department of Finance and Administration, letters, or 13 summarized oral testimony in the official minutes of the Arkansas Legislative 14 Council or Joint Budget Committee which relate to its passage and adoption. 15

16 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General 17 Assembly, that the Constitution of the State of Arkansas prohibits the 18 appropriation of funds for more than a one (1) year period; that the 19 effectiveness of this Act on July 1, 2015 is essential to the operation of 20 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the 21 22 effective date of this Act beyond July 1, 2015 could work irreparable harm 23 upon the proper administration and provision of essential governmental 24 programs. Therefore, an emergency is hereby declared to exist and this Act 25 being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2015. 26 27 28 29 APPROVED: 02/25/2015 30 31 32 33 34 35
