17	recognition of and appreciation for the service of the deceased person, the		
18	Department of Health may award one (1) United States flag to the deceased		
19	person's spouse or family.		
20	(b) As used in this section, "in the course of employment" means at		
21	any time when a person is:		
22	(1) On duty in the capacity for which he or she is licensed by		
23	the department; or		
24	(2) Performing an act ordinarily performed in the capacity for		
25	which he or she is licensed by the department, although the person is not on		
26	duty at the time.		
27	(c) This section does not limit or deny the right of any person or th		
28	person's survivors to any other benefits provided by law.
