8	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
9	General Assembly of the State of Arkansas that the Legislative Arkansas Blue
10	Ribbon Committee on Local 911 Systems expires on January 1, 2015; that the
11	Legislative Arkansas Blue Ribbon Committee on Local 911 Systems needs to
12	continue to study the impact of 911 emergency service to protect the lives,
13	health, and welfare of the state's residents in emergency situations,
14	specifically in rural areas of the state; that the Legislative Arkansas Blue
15	Ribbon Committee on Local 911 Systems should be extended immediately in order
16	to continue its mission and that this act is necessary to enhance the
17	benefits of the 911 emergency system to all residents of this state.
18	Therefore, an emergency is declared to exist, and this act being immediately
19	necessary for the preservation of the public peace, health, and safety shall
20	<u>become effective on:</u>
21	(1) The date of its approval by the Governor;
22	(2) If the bill is neither approved nor vetoed by the Governor,
23	the expiration of the period of time during which the Governor may veto the
24	<u>bill; or</u>
25	(3) If the bill is vetoed by the Governor and the veto is
26	overridden, the date the last house overrides the veto.
