9 HOME ON A STATE HIGHWAY; TO INCREASE THE WIDTH OF A

11 HIGHWAY BY THE ARKANSAS STATE HIGHWAY AND
12 TRANSPORTATION DEPARTMENT; AND FOR OTHER PURPOSES.

16 TO AMEND THE LAW TO INCREASE THE WIDTH OF
17 MANUFACTURED HOME AUTHORIZED FOR
18 TRANSPORT ON A STATE HIGHWAY BY THE
19 ARKANSAS STATE HIGHWAY AND TRANSPORTATION
20 DEPARTMENT.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 27-35-306(g), concerning the width of a
26 manufactured home authorized to travel on a highway and the requirement for
27 an escort vehicle, is amended to read as follows:

28 (g)(1) On any controlled-access, divided highway with four (4) or more
29 lanes, any manufactured home in excess of ~~fourteen feet six inches (14' 6")~~
30 fourteen feet nine inches (14' 9") in width shall be accompanied by one (1)
31 escort vehicle. The escort vehicle shall travel behind the manufactured home.

32 (2)(A) On all other highways, the movement of manufactured homes
33 in excess of twelve feet (12') in width through ~~fourteen feet six inches (14'~~
34 ~~6")~~ fourteen feet nine inches (14' 9") in width shall be accompanied by one
35 (1) escort vehicle. The escort vehicle shall travel in front of the
36 manufactured home.



1 (B) The movement of manufactured homes in excess of
2 ~~fourteen feet six inches (14' 6")~~ fourteen feet nine inches (14' 9") in width
3 shall be accompanied by two (2) escort vehicles. One (1) escort vehicle shall
4 travel in front of the manufactured home, and one (1) escort vehicle shall
5 travel behind the manufactured home.
