19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 *SECTION 1. Arkansas Code § 6-20-2511, concerning high growth school*
22 *districts, is amended to add an additional subsection to read as follows:*

23 *(h)(1) The commission shall annually determine which school districts*
24 *qualify as high-growth school districts under this section.*

25 *(2) Annually, by November 1, the commission shall prepare a list*
26 *of the qualified school districts and:*

27 *(A) Submit the list to the House Committee on Education*
28 *and the Senate Committee on Education; and*

29 *(B) Post the list on the website of the Division of Public*
30 *School Academic Facilities and Transportation.*

32 *SECTION 2. Arkansas Code § 6-20-2514(c), concerning the Academic*
33 *Facilities Extraordinary Circumstances Program, is amended to read as*
34 *follows:*

35 *(c) The division shall report to the ~~General Assembly by January 15,~~*
36 *2007 House Committee on Education and the Senate Committee on Education by*



1 October 15, 2015, on the development of the Academic Facilities Extraordinary
2 Circumstances Program and shall obtain formal legislative approval before
3 implementing the Academic Facilities Extraordinary Circumstances Program.

5 SECTION 3. Arkansas Code § 6-20-2515 is amended to read as follows:
6 6-20-2515. Review conferences.

7 (a) ~~After February 1, 2008,~~ a At least sixty (60) days before the
8 application deadline, a district may request and be granted by the Division
9 of Public School Academic Facilities and Transportation a review conference
10 that shall be held within twenty (20) working days after the date of request.

11 (b) The district may be advised through the review conference process
12 by an architectural and engineering firm if the school district pays the cost
13 for the advice from the architectural and engineering firm.

14 (c) The review conference shall consider the following:

15 (1) That the proposed project is academic;

16 (2) The application of the space calculation to the project
17 agreed upon by the district and the division;

18 (3) The wealth index of the district and the date at which the
19 wealth index will be applied to the partnership project if approved;

20 (4) The project cost promulgated by the Commission for Arkansas
21 Public School Academic Facilities and Transportation under § 6-20-2509 for
22 the project and the date on which the project cost data will be applied to
23 the partnership project if approved; ~~and~~

24 (5) A projected amount of state funding based on current
25 application of the wealth index and the project cost promulgated by the
26 commission under § 6-20-2509 to the planned project for planning purposes to
27 allow a projection of local funding share required; and

28 (6) Whether or not the proposed application meets all of the
29 technical requirements for partnership applications as set out in the
30 application guidelines and rules provided by the division before each
31 partnership application cycle.

32 (d) The division shall make a written record of the findings of the
33 review conference and provide a copy of the written record to the school
34 district within five (5) working days after the written record is finalized.
