21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code § 27-64-103 is amended to read as follows:

24 27-64-103. Mowing, installing, and maintaining sprinkler system of on
25 rights-of-way by adjoining landowners landowner.

26 (a)(1) The owners of properties which abut the ~~rights-of-way~~ right-of-
27 way of interstate, federal-aid primary, state, or county roads or highways in
28 this state may enter upon and mow ~~grass~~ grass, weeds, and other vegetation
29 on the portion of the ~~rights-of-way~~ right-of-way adjoining ~~their~~ the property
30 unless the ~~Arkansas State Highway and Transportation Department~~ department or
31 the county has installed barriers designed to prohibit ~~such mowing~~ entry or
32 unless the property ~~owners have~~ owner has received notice from the ~~Arkansas~~
33 ~~State Highway and Transportation Department~~ department or the county
34 restricting or prohibiting ~~such mowing~~ grass, weeds, and other vegetation.

35 (2) The owner of a property which abuts a right-of-way of a
36 state highway, may upon receipt of a permit from the department, install, use



1 and maintain a sprinkler system on the portion of the right-of-way adjoining
2 the property unless the department has installed a barrier designed to
3 prohibit entry.

4 (b) If ~~a person~~ an owner elects to mow ~~the grass, weeds, or other~~
5 vegetation road or highway or installs, uses, or maintains a sprinkler system
6 on the right-of-way adjoining his or her property, ~~he or she~~ the owner shall
7 do so at ~~his or her~~ the owner's own risk and shall have no right or claim for
8 damages against the ~~Arkansas State Highway and Transportation Department~~
9 department or any political subdivision of this state for loss of life, ~~or~~
10 injury, to his or her person or damage to his or her property while engaged
11 in the mowing activity or the installation, use, or maintenance of the
12 sprinkler system.

13 (c) ~~In addition~~ Subject to the limitations of subsections (a) and (b)
14 of this section, the owner ~~of the property~~ shall:

15 (1) ~~perform the mowing~~ Mow the grass, weeds, or other vegetation
16 and install, use, and maintain the sprinkler system in a manner that does not
17 obstruct or pose danger to motorists in their lawful use of the public road
18 or highway; and

19 (2) ~~He or she shall be~~ Be liable for any loss, injury, or damage
20 to the life, person, or property of ~~motorists lawfully using the highway,~~
21 others which that is caused by any ~~action or~~ negligence in connection with
22 the mowing grass, weeds, or other vegetation or installing, using, or
23 maintaining the sprinkler system ~~of~~ on the highway right-of-way.
