15 AN ACT FOR THE ARKANSAS CRIME INFORMATION
16 CENTER APPROPRIATION FOR THE 2016-2017
17 FISCAL YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Arkansas Crime Information Center for the 2016-2017 fiscal year, the
24 following maximum number of regular employees.

16 There is hereby appropriated, to the Arkansas Crime Information Center, to be
17 payable from the Crime Information System Fund, for maintenance and operating
18 expenses of the Arkansas Crime Information Center - Arkansas Real-Time Scrap
19 Metal Logbook for the fiscal year ending June 30, 2017, the following:

25 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USE OF
27 CONTINGENCY APPROPRIATION AND FUNDING. In the event additional appropriation
28 becomes necessary that is not authorized or contemplated in Section 2 of this
29 Act and circumstances make it necessary for the Arkansas Crime Information
30 Center to request additional appropriation to carry out the objectives of the
31 Agency, the Contingency Appropriation authorized herein may be used for
32 regular salaries, personal services matching and maintenance and general
33 operation line item appropriations authorized for such programs in this Act.
34 Funding for the Contingency Appropriation authorized herein may be
35 transferred to the appropriate fund or fund account from such excess funds as
36 the Director of the Arkansas Crime Information Center may determine are

1 available from criminal background check fees deposited on behalf of the
2 Arkansas Crime Information Center. Use of the contingency appropriation and
3 funding authorized in this Act shall be approved by the Chief Fiscal Officer
4 of the State and the Arkansas Legislative Council or Joint Budget Committee.

5 Determining the maximum number of employees and the maximum amount of
6 appropriation and general revenue funding for a state agency each fiscal year
7 is the prerogative of the General Assembly. This is usually accomplished by
8 delineating such maximums in the appropriation act(s) for a state agency and
9 the general revenue allocations authorized for each fund and fund account by
10 amendment to the Revenue Stabilization law. Further, the General Assembly
11 has determined that the Arkansas Crime Information Center may operate more
12 efficiently if some flexibility is provided to the Arkansas Crime Information
13 Center authorizing broad powers under this Section. Therefore, it is both
14 necessary and appropriate that the General Assembly maintain oversight by
15 requiring prior approval of the Legislative Council or Joint Budget Committee
16 as provided by this section. The requirement of approval by the Legislative
17 Council or Joint Budget Committee is not a severable part of this section.
18 If the requirement of approval by the Legislative Council or Joint Budget
19 Committee is ruled unconstitutional by a court of competent jurisdiction,
20 this entire section is void.

21 The provisions of this section shall be in effect only from July 1, ~~2015~~
22 2016 through June 30, ~~2016~~ 2017.

23
24 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
25 authorized by this act shall be limited to the appropriation for such agency
26 and funds made available by law for the support of such appropriations; and
27 the restrictions of the State Procurement Law, the General Accounting and
28 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
29 Procedures and Restrictions Act, or their successors, and other fiscal
30 control laws of this State, where applicable, and regulations promulgated by
31 the Department of Finance and Administration, as authorized by law, shall be
32 strictly complied with in disbursement of said funds.

33
34 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
35 Assembly that any funds disbursed under the authority of the appropriations
36 contained in this act shall be in compliance with the stated reasons for

1 which this act was adopted, as evidenced by the Agency Requests, Executive
2 Recommendations and Legislative Recommendations contained in the budget
3 manuals prepared by the Department of Finance and Administration, letters, or
4 summarized oral testimony in the official minutes of the Arkansas Legislative
5 Council or Joint Budget Committee which relate to its passage and adoption.
6

7 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
8 General Assembly, that the Constitution of the State of Arkansas prohibits
9 the appropriation of funds for more than a one (1) year period; that the
10 effectiveness of this Act on July 1, 2016 is essential to the operation of
11 the agency for which the appropriations in this Act are provided, and that in
12 the event of an extension of the legislative session, the delay in the
13 effective date of this Act beyond July 1, 2016 could work irreparable harm
14 upon the proper administration and provision of essential governmental
15 programs. Therefore, an emergency is hereby declared to exist and this Act
16 being necessary for the immediate preservation of the public peace, health
17 and safety shall be in full force and effect from and after July 1, 2016.
