The Chief Fiscal Officer of the State 15 may transfer from time to time on his or her books and those of the State 16 Treasurer and the Auditor of the State funding which is made available from 17 General Improvement Funds allocated and distributed to the Department of 18 Finance and Administration - Building Authority Division in an amount not to 19 exceed three million dollars (\$3,000,000) from the General Improvement Fund 20 or its successor fund or fund accounts to the Sustainable Building Design 21 Revolving Loan Fund to provide funds for the appropriation provided herein or 22 for appropriation authority as may be provided by law to provide loans to 23 agencies for the Sustainable Building Design Program.

24 The provisions of this section shall be in effect only from July 1, 2016 25 <u>2017</u> through June 30, 2017 <u>2018</u>.

27 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING 28 29 TRANSFER - FEDERAL FUNDS. From time to time, the Chief Fiscal Officer of the State may transfer on his or her books and those of the State Treasurer and 30 31 the Auditor of the State the sum not to exceed twelve million dollars 32 (\$12,000,000) from Federal Funds as determined by the Chief Fiscal Officer of 33 the State to the Sustainable Building Design Revolving Loan Fund to provide 34 funds for the appropriations herein.

SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING 3 4 TRANSFER - CASH FUND ACCOUNT. The Department of Finance and Administration -5 Building Authority Division is authorized to transfer any unspent funds 6 remaining in any cash fund account established for the management of a state 7 owned facility managed by, but not owned by, the Department of Finance and 8 Administration - Building Authority Division to the Department of Finance and 9 Administration - Building Authority Maintenance Fund to support the 10 facility's Maintenance and Operations appropriations.

14 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING 16 TRANSFER - INSURANCE DEPARTMENT TRUST FUND. Department of Finance and 17 Administration - Building Authority Division may from time to time as may be 18 necessary and in such amounts as may be necessary and with the approval of 19 the Chief Fiscal Officer of the State, request a transfer of funds from the 20 Insurance Department Trust Fund to the Building Authority Division Real 21 Estate Fund to provide funds for land acquisition and building construction 22 in an amount not to exceed the dollar amount appropriated in the Acquisition 23 and Maintenance Section. SECTION 26. LEGISLATIVE INTENT. It is the intent of the General 5 6 Assembly that any funds disbursed under the authority of the appropriations 7 contained in this act shall be in compliance with the stated reasons for 8 which this act was adopted, as evidenced by the Agency Requests, Executive 9 Recommendations and Legislative Recommendations contained in the budget 10 manuals prepared by the Department of Finance and Administration, letters, or 11 summarized oral testimony in the official minutes of the Arkansas Legislative 12 Council or Joint Budget Committee which relate to its passage and adoption. 13

14 SECTION 27. EMERGENCY CLAUSE. It is found and determined by the 15 General Assembly, that the Constitution of the State of Arkansas prohibits 16 the appropriation of funds for more than a one (1) year period; that the 17 effectiveness of this Act on July 1, 2017 is essential to the operation of 18 the agency for which the appropriations in this Act are provided, and that in 19 the event of an extension of the legislative session, the delay in the 20 effective date of this Act beyond July 1, 2017 could work irreparable harm upon the proper administration and provision of essential governmental 21 22 programs.
