9 AND OPERATING EXPENSES FOR THE ARKANSAS STATE  
10 UNIVERSITY - ARKANSAS BIOSCIENCES INSTITUTE FOR THE  
11 FISCAL YEAR ENDING JUNE 30, 2018; AND FOR OTHER  
12 PURPOSES.

15 AN ACT FOR THE ARKANSAS STATE UNIVERSITY  
16 - ARKANSAS BIOSCIENCES INSTITUTE  
17 APPROPRIATION FOR THE 2017-2018 FISCAL

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - ARKANSAS BIOSCIENCES INSTITUTE. There is  
25 hereby established for the Arkansas State University - Arkansas Biosciences  
26 Institute for the 2017-2018 fiscal year, the following maximum number of  
27 regular employees.

25 SECTION 2. EXTRA HELP - ARKANSAS BIOSCIENCES INSTITUTE. There is  
 26 hereby authorized, for the Arkansas State University - Arkansas Biosciences  
 27 Institute for the 2017-2018 fiscal year, the following maximum number of  
 28 part-time or temporary employees, to be known as "Extra Help", payable from  
 29 funds appropriated herein for such purposes: fifty (50) temporary or part-  
 30 time employees, when needed, at rates of pay not to exceed those provided in  
 31 the Uniform Classification and Compensation Act, or its successor, or this  
 32 act for the appropriate classification.

34 SECTION 3. APPROPRIATION - ARKANSAS BIOSCIENCES INSTITUTE. There is  
 35 hereby appropriated, to the Arkansas State University, to be payable from the  
 36 Arkansas Biosciences Institute Program Account of the Tobacco Settlement

1 Program Fund, for personal services and operating expenses of the Arkansas  
 2 State University - Arkansas Biosciences Institute for the fiscal year ending  
 3 June 30, 2018, the following:

18 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER  
 20 RESTRICTIONS. The appropriations provided in this act shall not be  
 21 transferred under the provisions of Arkansas Code 19-4-522, but only as  
 22 provided by this act.

23 The provisions of this section shall be in effect only from July 1, ~~2016~~  
 24 2017 through June 30, ~~2017~~ 2018.

26 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER  
 28 PROVISIONS. The state-supported institution of higher education in this act  
 29 may transfer appropriations between the various line items within each  
 30 appropriation contained in this appropriation act. Such transfers shall be  
 31 made only after the approval of the Department of Higher Education and the  
 32 Chief Fiscal Officer of the State, and the approval of the Legislative  
 33 Council or Joint Budget Committee.

34 The General Assembly has determined that the institution in this act could  
 35 be operated more efficiently if some flexibility is given to that institution  
 36 and that flexibility is being accomplished by providing authority to transfer

1 between items of appropriation made by this act. Since the General Assembly  
2 has granted the institution broad powers under the transfer of  
3 appropriations, it is both necessary and appropriate that the General  
4 Assembly maintain oversight of the utilization of the transfers by requiring  
5 prior approval of the Legislative Council or Joint Budget Committee in the  
6 utilization of the transfer authority. Therefore, the requirement of  
7 approval by the Legislative Council or Joint Budget Committee is not a  
8 severable part of this section. If the requirement of approval by the  
9 Legislative Council or Joint Budget Committee is ruled unconstitutional by a  
10 court of competent jurisdiction, this entire section is void.

11 The provisions of this section shall be in effect only from July 1, ~~2016~~  
12 2017 through June 30, ~~2017~~ 2018.

14 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
16 POSITIONS. (a) Nothing in this act shall be construed as a commitment of the  
17 State of Arkansas or any of its agencies or institutions to continue funding  
18 any position paid from the proceeds of the Tobacco Settlement in the event  
19 that Tobacco Settlement funds are not sufficient to finance the position.  
20 (b) State funds will not be used to replace Tobacco Settlement funds when  
21 such funds expire, unless appropriated by the General Assembly and authorized  
22 by the Governor.  
23 (c) A disclosure of the language contained in (a) and (b) of this Section  
24 shall be made available to all new hire and current positions paid from the  
25 proceeds of the Tobacco Settlement by the Tobacco Settlement Commission.  
26 (d) Whenever applicable the information contained in (a) and (b) of this  
27 Section shall be included in the employee handbook and/or Professional  
28 Services Contract paid from the proceeds of the Tobacco Settlement.

29 The provisions of this section shall be in effect only from July 1, ~~2016~~  
30 2017 through June 30, ~~2017~~ 2018.

31  
32 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
34 COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act  
35 shall be limited to the appropriation for such agency and funds made  
36 available by law for the support of such appropriations; and the restrictions

1 of the State Purchasing Law, the General Accounting and Budgetary Procedures  
 2 Law, the Regular Salary Procedures and Restrictions Act, or their successors,  
 3 and other fiscal control laws of this State, where applicable, and  
 4 regulations promulgated by the Department of Finance and Administration, as  
 5 authorized by law, shall be strictly complied with in disbursement of said  
 6 funds.

 8 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

10 LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds  
 11 disbursed under the authority of the appropriations contained in this act  
 12 shall be in compliance with the stated reasons for which this act was  
 13 adopted, as evidenced by Initiated Act 1 of 2000, the Agency Requests,  
 14 Executive Recommendations and Legislative Recommendations contained in the  
 15 budget manuals prepared by the Department of Finance and Administration,  
 16 letters, or summarized oral testimony in the official minutes of the Arkansas  
 17 Legislative Council or Joint Budget Committee which relate to its passage and  
 18 adoption.

19  
 20 SECTION 9. EMERGENCY CLAUSE. It is found and determined by the General  
 21 Assembly, that the Constitution of the State of Arkansas prohibits the  
 22 appropriation of funds for more than a one (1) year period; that the  
 23 effectiveness of this Act on July 1, 2017 is essential to the operation of  
 24 the agency for which the appropriations in this Act are provided, and that in  
 25 the event of an extension of the legislative session, the delay in the  
 26 effective date of this Act beyond July 1, 2017 could work irreparable harm  
 27 upon the proper administration and provision of essential governmental  
 28 programs. Therefore, an emergency is hereby declared to exist and this Act  
 29 being necessary for the immediate preservation of the public peace, health  
 30 and safety shall be in full force and effect from and after July 1, 2017.
