18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code § 6-12-316 is repealed.

21 ~~6-12-316. Salary.~~

22 ~~(a)(1) Each executive council may determine the salary of the school~~
23 ~~district coordinator and the allowances for travel, clerical support, office,~~
24 ~~and other expenses.~~

25 ~~(2) The county shall provide office space and other appropriate~~
26 ~~facilities to the school district coordinator and his or her staff at the~~
27 ~~county seat free of charge as was previously provided to the county school~~
28 ~~supervisor and county board of education.~~

29 ~~(b) The chair of the executive council may call a meeting in June each~~
30 ~~year for the consideration of these matters.~~

31 ~~(c) All allowances for office expense, travel, and clerical support~~
32 ~~shall be based upon detailed budgets submitted by the school district~~
33 ~~coordinator and approved by the executive council.~~

34 ~~(d) With the approval of the executive council, the school district~~
35 ~~coordinator is authorized to hire necessary clerical and other assistants.~~

36 ~~(e) The allowances to the school district coordinator and members of~~



1 ~~the executive council for travel expense, meals, and hotels shall not be in~~
2 ~~excess of the allowance for state employees.~~

3 ~~(f)(1) The expense allowed under this section may be paid from the~~
4 ~~unapportioned county general school fund to a special fund by the county~~
5 ~~treasurer or the common fund of the county or any other source.~~

6 ~~(2) Payments allowed under this section shall be made only after~~
7 ~~presentation of invoices, statements, itemized expense accounts, or payroll~~
8 ~~vouchers signed by the school district coordinator and the chair of the~~
9 ~~executive council.~~

10 ~~(g) If the person employed as the school district coordinator was~~
11 ~~previously employed in a position that was eligible to participate in the~~
12 ~~Arkansas Teacher Retirement System, the school district coordinator shall be~~
13 ~~eligible to continue to participate in the system.~~
