20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Because Acts 1997, No. 208, § 1, applies to numerous titles
23 of the Arkansas Code and because the language of the section has been noted
24 at multiple locations in the Arkansas Code and also codified as § 22-4-408,
25 thus achieving the undesirable result of having identical statutory language
26 both codified and noted in the Arkansas Code, Arkansas Code § 22-4-408 is
27 repealed, and Acts 1997, No. 208, § 1, is reenacted as uncodified language to
28 read as follows:
29

30 ~~22-4-408. Legislative intent and purpose.~~

31 ~~The General Assembly hereby acknowledges that many of the laws~~
32 ~~relating to individuals with disabilities are antiquated, functionally~~
33 ~~outmoded, 31 derogatory, and ambiguous or are inconsistent with more recently~~

 10 SECTION 2. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT.

11 It is the intent of the General Assembly that:

12 (1) The enactment and adoption of this act shall not expressly
 13 or impliedly repeal an act passed during the regular session of the Ninety-
 14 First General Assembly;

15 (2) To the extent that a conflict exists between an act of the
 16 regular session of the Ninety-First General Assembly and this act:

17 (A) The act of the regular session of the Ninety-First
 18 General Assembly shall be treated as a subsequent act passed by the General
 19 Assembly for the purpose of:

20 (i) Giving the act of the regular session of the
 21 Ninety-First General Assembly its full force and effect; and

22 (ii) Amending or repealing the appropriate parts of
 23 the Arkansas Code of 1987; and

24 (B) Section 1-2-107 shall not apply; and

25 (3) This act shall make only technical, not substantive, changes
 26 to the Arkansas Code of 1987.
