16 CONCERNING THE ARKANSAS SCHOOL FOR

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 6-42-302(a), concerning the Arkansas School
23 for Mathematics, Sciences, and the Arts, is amended to read as follows:

24 (a) The Arkansas School for Mathematics, Sciences, and the Arts shall
25 be a residential high school for ~~eleventh-grade and twelfth-grade~~ students
26 who exhibit outstanding academic credentials and who have the ability to
27 undertake course work in an environment and with demands similar to those of
28 a university.
29

30 SECTION 2. Arkansas Code § 6-42-303(c)(1)(A), concerning meetings of
31 the Board of Visitors of the Arkansas School for Mathematics, Sciences, and
32 the Arts, is amended to read as follows:

33 (c)(1)(A) The board of visitors shall meet ~~monthly~~ at least quarterly
34 as the board of visitors determines and shall elect from its voting members a
35 chair, a vice chair, and a secretary.

1 SECTION 3. Arkansas Code § 6-42-304(a)(2)(C), concerning the
2 transition to becoming a campus of the University of Arkansas, is repealed.

3 ~~(C) Aid in the orderly transition of the school as it~~
4 ~~becomes a campus of the University of Arkansas;~~

6 SECTION 4. Arkansas Code § 6-42-304(c), concerning tuition, fees, or
7 room and board, is amended to read as follows:

8 (c)(1) Students who are residents of this state selected to attend the
9 school shall not be required to pay tuition, fees, or room and board.

10 (2) Students who are residents of other countries selected to
11 attend the school shall pay the cost of tuition, fees, and room and board as
12 established by the Board of Trustees of the University of Arkansas.
