15 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 17 ADDITIONAL TEACHING LOAD. Instructional full-time staff and ten (10) extra 18 help positions at Northwest Technical Institute, may be paid up to seventy-19 five dollars (\$75) per clock hour for the fiscal year ending June 30, 2018 20 2019, for noncredit teaching assignments; or up to five hundred fifty dollars 21 (\$550) per semester hour for the fiscal year ending June 30, 2018 2019, for 22 teaching courses beyond the defined teaching load; and the employee's maximum 23 allowable salary may be exceeded by such amount; provided, however, that such 24 additional teaching load may not exceed one hundred fifty (150) clock hours 25 or nine (9) semester credit hours per school year. Further, the provisions 26 of this section shall only apply to credit and noncredit courses that are 27 funded by Private Industry.

28 The provisions of this section shall be in effect only from July 1, 2017
29 <u>2018</u> through June 30, 2018 <u>2019</u>.

31 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA 33 HELP RESTRICTION. No employee at Northwest Technical Institute, who is 34 employed as "Extra Help" may exceed eighty-five percent (85%) of the maximum 35 annual salary for a comparable position as authorized under Arkansas Code § 36 21-5-201 et seq. during any fiscal year, nor shall such employee be employed 1 for a period of time to exceed fourteen hundred (1400) hours in any single
2 fiscal year.

3 The provisions of this section shall be in effect only from July 1, 2017
4 <u>2018</u> through June 30, 2018 <u>2019</u>.

6 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 7 authorized by this act shall be limited to the appropriation for such agency 8 and funds made available by law for the support of such appropriations; and 9 the restrictions of the State Procurement Law, the General Accounting and 10 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 11 Procedures and Restrictions Act, or their successors, and other fiscal 12 control laws of this State, where applicable, and regulations promulgated by 13 the Department of Finance and Administration, as authorized by law, shall be 14 strictly complied with in disbursement of said funds.

16 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General 17 Assembly that any funds disbursed under the authority of the appropriations 18 contained in this act shall be in compliance with the stated reasons for 19 which this act was adopted, as evidenced by the Agency Requests, Executive 20 Recommendations and Legislative Recommendations contained in the budget 21 manuals prepared by the Department of Finance and Administration, letters, or 22 summarized oral testimony in the official minutes of the Arkansas Legislative 23 Council or Joint Budget Committee which relate to its passage and adoption. 24
